2	(a) There is established the Arkansas Silver Alert System to be		
3	administered by the Division of Arkansas State Police.

12	(a) There is established a standardized system to aid in the search of		
13	missing adults to be known as the Arkansas Purple Alert System.		
14	(b) The Division of the Arkansas State Police shall serve as the		
15	coordinating law enforcement agency to disseminate appropriate regional		
16	alerts under the Arkansas Purple Alert System.		
17	(c) The Arkansas Purple Alert System shall be used for a missing adult		
18	who does not meet the criteria for activation of the Arkansas Silver Alert		
19	<pre>System:</pre>		
20	(1) Who has:		
21	(A) A mental or cognitive disability that is not		
22	Alzheimer's disease or a dementia-related disorder;		
23	(B) An intellectual disability, developmental disability,		
24	or brain injury; or		
25	(C) Another physical, mental, or emotional disability that		
26	is not related to substance abuse;		
27	(2) Whose disappearance indicates a credible threat of immediate		
28	danger or serious bodily harm to himself or herself, as determined by the

32	returned to safety without law enforcement intervention.		
33	(d) The Arkansas Purple Alert System shall have safeguards in place to

1	(2) Provides for the protection of the privacy, dignity, and		
2	independence of the missing adult;

4	dissemination of sensitive health information;

6	related information to the geographic areas where the missing adult could		
7	reasonably be; and		
8	(5) Only occurs when there is sufficient descriptive information		
9	about the missing adult and the circumstances surrounding his or her		
10	disappearance to indicate that activating an alert is likely to help locate
