28	(a)(l) As used	in this section, "communication device	e" means any
29	public or private inst	rumentality used or useful in the tra	nsmission of a
30	writing, sign, signal,	picture, or sound of any kind.	
31	<u>(2) "Comm</u>	unication device" includes without li	<u>mitation mail,</u>
32	telephone, wire, radio	, and any other means of communication	<u>n .</u>
33	(b) A person con	mmits the offense of unlawful use of	a communication
34	device during the comm	ission of a human trafficking offense	if he or she
35	knowingly uses any communication device in committing or in causing or		
36	facilitating the commi	ssion of any act constituting a:	

1	(1) Felony under this chapter; or			
2	(2) Felony attempt, solicitation, or conspiracy to commit an			
3	offense under this chapter.			
4	(c) Each use of a communication device is a separate offense under			
5	this section.			
6	(d) Unlawful use of a communication device during the commission of a			
7	human trafficking offense is a Class C felony.
