22	SECTION 1. Arkansas Code	Title 23, Chapter 117, is amended to add an	
23	additional section to read as f	ollows:	
24	23-117-103. Self-exclusi	on list — Definition.	
25	(a) As used in this sect	ion, "self-exclusion" or "self-excluded" means	
26	a declaration from an individua	l to a casino that he or she would like to be	
27	excluded from entering the casi	no's facility.	
28	(b)(l) At the discretion	of the Director of the Arkansas Racing	
29	Commission, the Arkansas Racing	Commission shall maintain a statewide self-	
30	exclusion list, and the commiss	ion shall:	
31	(A) Join a m	ulti-state or national self-exclusion program	
32	operated to ensure responsible	gaming services; or	
33	(B) Enter in	to an agreement with another state or states	
34	for the sharing and mutual enfo	rcement of each state's respective self-	
35	exclusion list.		
36	(2) The self-exclu	sion list maintained under subdivision (b)(l)	

1	of this section shall serve as the definitive list of self-excluded		
2	individuals in lieu of a separate list maintained by each casino to comply		
3	with rules regarding a casino's obligations related to self-excluded		
4	individuals.		
5	(c) This section does not permit the commission or an entity involved		
6	under subsection (b) of this section to disclose the name or information of		
7	an individual on the self-exclusion list without the individual's		
8	authorization.		
9	(d) Any cost associated with commission requirements under subsection		
10	(b) of this section may be paid from an assessment paid by each casino.		
11	(e)(l) An individual is not permitted to add an individual other than		
12	himself or herself onto the self-exclusion list.		
13	(2) A casino shall require an individual to present his or her		
14	identification to confirm identity before placement on the self-exclusion		
15	<u>list.</u>		
16	(f) The commission shall promulgate rules to implement and enforce		
17	this section, including without limitation rules concerning:		
18	(1) The transition from a single-location self-exclusion list to		
19	a statewide or broader self-exclusion list;		
20	(2) An option for a self-excluded individual to select the state		
21	with which the commission is authorized to share his or her information;		
22	(3) A means for an individual to join a self-exclusion list in		
23	multiple states using a single form; and		
24	(4) A means for an individual to remove himself or herself from		
25	the self-exclusion list.
