26	the immediately preceding general election unless changed by order of the

Arkansas Code § 7-5-418(a)(1)(A), concerning early voting, is amended to read as follows: (a)(1)(A) Except as provided in subdivision (a)(1)(B) of this section, early voting shall be available to any qualified elector who applies to the county clerk's designated early voting location within the county seat, beginning fifteen (15) days before a preferential primary or general election between the hours of 8:00 a.m. and 6:00 p.m. Monday through Friday and 10:00 a.m. and 4:00 p.m. Saturday and ending at 5:00 p.m. on the Monday before the election. SECTION 4.
