9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
10 AND OPERATING EXPENSES FOR THE DEPARTMENT OF HUMAN  
11 SERVICES - DIVISION OF CHILDREN AND FAMILY SERVICES  
12 FOR THE FISCAL YEAR ENDING JUNE 30, 2026; AND FOR  
13 OTHER PURPOSES.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
26 for the Department of Human Services - Division of Children and Family  
27 Services for the 2025-2026 fiscal year, the following maximum number of  
28 regular employees.

34 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for  
 35 the Department of Human Services - Division of Children and Family Services  
 36 for the 2025-2026 fiscal year, the following maximum number of part-time or

1 temporary employees, to be known as "Extra Help", payable from funds  
 2 appropriated herein for such purposes: sixty-five (65) temporary or part-time  
 3 employees, when needed, at rates of pay not to exceed those provided in the  
 4 Uniform Classification and Compensation Act, or its successor, or this act  
 5 for the appropriate classification.

 7 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 8 to the Department of Human Services, to be payable from the paying account as  
 9 determined by the Chief Fiscal Officer of the State, for personal services  
 10 and operating expenses of the Department of Human Services - Division of  
 11 Children and Family Services for the fiscal year ending June 30, 2026, the

36 SECTION 7. APPROPRIATION - SAFE HARBOR GRANTS. There is hereby

1 appropriated, to the Department of Human Services, to be payable from the  
 2 Safe Harbor Fund for Sexually Exploited Children, for grants to Children’s  
 3 Advocacy Centers statewide for services and treatment for sexually exploited  
 4 children by the Department of Human Services - Division of Children and  
 5 Family Services - Safe Harbor Grants for the fiscal year ending June 30,  
 6 2026, the following:

 12 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 13 authorized by this act shall be limited to the appropriation for such agency  
 14 and funds made available by law for the support of such appropriations; and  
 15 the restrictions of the State Procurement Law, the General Accounting and  
 16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 17 Procedures and Restrictions Act, or their successors, and other fiscal  
 18 control laws of this State, where applicable, and regulations promulgated by  
 19 the Department of Finance and Administration, as authorized by law, shall be  
 20 strictly complied with in disbursement of said funds.

21  
 22 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General  
 23 Assembly that any funds disbursed under the authority of the appropriations  
 24 contained in this act shall be in compliance with the stated reasons for  
 25 which this act was adopted, as evidenced by the Agency Requests, Executive  
 26 Recommendations and Legislative Recommendations contained in the budget  
 27 manuals prepared by the Department of Finance and Administration, letters, or  
 28 summarized oral testimony in the official minutes of the Arkansas Legislative  
 29 Council or Joint Budget Committee which relate to its passage and adoption.

30  
 31 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the  
 32 General Assembly, that the Constitution of the State of Arkansas prohibits  
 33 the appropriation of funds for more than a one (1) year period; that the  
 34 effectiveness of this Act on July 1, 2025 is essential to the operation of  
 35 the agency for which the appropriations in this Act are provided, and that in  
 36 the event of an extension of the legislative session, the delay in the

1 effective date of this Act beyond July 1, 2025 could work irreparable harm  
2 upon the proper administration and provision of essential governmental  
3 programs. Therefore, an emergency is hereby declared to exist and this Act  
4 being necessary for the immediate preservation of the public peace, health  
5 and safety shall be in full force and effect from and after July 1, 2025.
