22 SECTION 25. APPROPRIATION - SENIOR MEDICARE PATROL SMP. There is
 23 hereby appropriated, to the Department of Commerce, to be payable from the
 24 federal funds as designated by the Chief Fiscal Officer of the State, to
 25 empower and assist Medicare beneficiaries to prevent, detect, and report
 26 health care fraud, errors, and abuse through outreach, counseling and
 27 education by the Department of Commerce - State Insurance Department for the
 28 fiscal year ending June 30, 2027, the following:

7 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
9 TRANSFER PROVISION. In the event the State Insurance Department is unable to
10 maintain a full roster of examination personnel, and upon approval of the
11 Chief Fiscal Officer of the State, the resulting unused appropriations in
12 Regular Salaries, Extra Help, and Personal Services Matching may be
13 transferred to the Professional Services special line item for the purpose of
14 contracting with qualified individuals or firms for examination assistance.
15 The provisions of this section shall be in effect only from July 1, ~~2025~~

18 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

20 EXPENDITURE. The proceeds from the reimbursement of travel expenses received
21 by the Arkansas Insurance Department, shall be deposited into the same State
22 Treasury Fund or Fund Account from which the original travel expenditure was
23 incurred as a refund to expenditure to the credit of the appropriation from
24 which the original expenditure was made.
25 The provisions of this section shall be in effect only from July 1,
26 ~~2025~~ 2026 through June 30, ~~2026~~ 2027.

28 *SECTION 28. Arkansas Code § 23-86-119(a)(1), concerning information*
29 *required to be disclosed to policyholders, is amended to read as follows:*
30 *(a)(1) Upon request from a policyholder with more than ~~fifty (50)~~*
31 *twenty-five (25) insured employees under a comprehensive group health*
32 *insurance policy, an insurer issuing or delivering a group accident and*
33 *health insurance policy in this state shall provide to the policyholder the*
34 *following information for the most recent twelve-month period or for the*
35 *entire period of coverage, whichever is shorter:*
36 *(A)(i) A monthly premium, claims, and enrollment report.*

1 (ii) A monthly premium, claims, and enrollment
2 report required under subdivision (a)(1)(A)(i) of this section shall include
3 without limitation:

- 4 (a) Medical claims on a paid basis by month;
- 5 (b) Pharmacy claims on a paid basis by month;
- 6 (c) Premiums paid by month; and
- 7 (d) Total number of enrolled members,
8 including dependents by month; and

9 (B)(i) A high-cost claimant report that is applicable to
10 an enrolled member with claims exceeding ten thousand dollars (\$10,000).

11 (ii) A high-cost claimant report required under
12 subdivision (a)(1)(B)(i) of this section shall include for each enrolled
13 member:

- 14 (a) Current coverage status, either active or
15 terminated;
- 16 (b) Total medical claims on a paid basis by
17 month; and
- 18 (c) Total pharmacy claims on a paid basis by
19 month.

20
21 SECTION 29. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
22 authorized by this act shall be limited to the appropriation for such agency
23 and funds made available by law for the support of such appropriations; and
24 the restrictions of the State Procurement Law, the General Accounting and
25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
26 Procedures and Restrictions Act, or their successors, and other fiscal
27 control laws of this State, where applicable, and regulations promulgated by
28 the Department of Finance and Administration, as authorized by law, shall be
29 strictly complied with in disbursement of said funds.

30
31 SECTION 30. LEGISLATIVE INTENT. It is the intent of the General
32 Assembly that any funds disbursed under the authority of the appropriations
33 contained in this act shall be in compliance with the stated reasons for
34 which this act was adopted, as evidenced by the Agency Requests, Executive
35 Recommendations and Legislative Recommendations contained in the budget
36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 31. EMERGENCY CLAUSE. It is found and determined by the
5 General Assembly, that the Constitution of the State of Arkansas prohibits
6 the appropriation of funds for more than a one (1) year period; that the
7 effectiveness of this Act on July 1, 2026 is essential to the operation of
8 the agency for which the appropriations in this Act are provided, and that in
9 the event of an extension of the legislative session, the delay in the
10 effective date of this Act beyond July 1, 2026 could work irreparable harm
11 upon the proper administration and provision of essential governmental
12 programs. Therefore, an emergency is hereby declared to exist and this Act
13 being necessary for the immediate preservation of the public peace, health
14 and safety shall be in full force and effect from and after July 1, 2026.
