9 RIGHTS-OF-WAY; AND FOR OTHER PURPOSES.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. Arkansas Code 27-51-1302 is amended to read as follows:
20 27-51-1302. Stopping, standing, or parking prohibited in specified
21 places.

22 (a) No person shall stop, stand, or park a vehicle, except when
23 necessary to avoid conflict with other traffic or in compliance with the
24 directions of a police officer or traffic-control device, in any of the
25 following places:

- 26 (1) On a sidewalk;
- 27 (2) In front of a public or private driveway;
- 28 (3) Within an intersection;
- 29 (4) Within fifteen feet (15') of a fire hydrant;
- 30 (5) On a crosswalk;
- 31 (6) Within twenty feet (20') of a crosswalk at an intersection;
- 32 (7) Within thirty feet (30') upon the approach to any flashing
33 beacon, stop sign, or traffic-control signal located at the side of a
34 roadway;
- 35 (8) Between a safety zone and the adjacent curb or within thirty
36 feet (30') of points on the curb immediately opposite the ends of a safety



1 zone, unless the local traffic authority indicates a different length by
2 signs or markings;

3 (9) Within fifty feet (50') of the nearest rail of a railroad
4 crossing;

5 (10) Within twenty feet (20') of the driveway entrance to any
6 fire station and on the side of a street opposite the entrance to any fire
7 station within seventy-five feet (75') of the entrance when properly
8 signposted;

9 (11) Alongside or opposite any street excavation or obstruction
10 when stopping, standing, or parking would obstruct traffic;

11 (12) On a roadway side of any vehicle stopped or parked at the
12 edge of a curb or street;

13 (13) Upon any bridge or other elevated structure upon a highway
14 or within a highway tunnel;

15 (14) At any place where official signs prohibit stopping; or

16 (15) On the shoulders, median, ramps, and all other highway
17 rights-of-way along an interstate highway, except in designated parking
18 areas.

19 (b) No person shall move a vehicle not owned by the person into any
20 such prohibited area or away from a curb a distance that is unlawful.
