## For An Act To Be Entitled

9 "AN ACT TO AMEND ARKANSAS CODE 27-14-902 TO PROVIDE  
10 FOR TRANSFER OF MOTOR VEHICLE REGISTRATION AND LICENSE  
11 PLATES TO OR FROM LEASED NONCOMMERCIAL MOTOR VEHICLES;  
12 TO AMEND ARKANSAS CODE 27-14-1012 TO REQUIRE VEHICLE  
13 REGISTRATION RENEWAL NOTICES BE MAILED NOT LESS THAN  
14 THIRTY (30) DAYS PRIOR TO REGISTRATION EXPIRATION; AND  
15 FOR OTHER PURPOSES. "

## Subtitle

17 "TO ALLOW THE TRANSFER OF MOTOR VEHICLE  
18 LICENSE PLATES TO LEASED VEHICLES AND TO  
19 REQUIRE REGISTRATION RENEWAL NOTICES BE  
20 MAILED NOT LESS THAN 30 DAYS PRIOR TO  
21 EXPIRATION. "

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
26

27 SECTION 1. Arkansas Code § 27-14-902 is amended to read as follows:

28 "27-14-902. Transfer or assignment by owner generally.

29 (a)(1) Whenever the owner or lessee of a registered vehicle transfers  
30 or assigns his title, or interest thereto, the registration of the vehicle  
31 shall expire.

32 (2) The owner shall remove the license plate or plates and any  
33 plate sticker, metal tab, or decal therefrom and forward them to the office,  
34 or he may have such plate or plates and plate sticker, metal tab, or decal,  
35 and the registration number thereon, assigned to another vehicle, upon payment  
36 of the fees required by law and subject to the rules and regulations of the

1 office.

2 (b)(1) The owner or lessee shall pay a transfer fee of one dollar  
3 (\$1.00).

4 (2) If the fee for registration and licensing the vehicle to be  
5 registered is greater than the registration fee paid for the vehicle  
6 originally licensed, then the office shall, in addition, collect an amount  
7 equal to the excess payable for the vehicle to be registered.

8 (3) No refund will be due in the event that the fee for  
9 registration and licensing the vehicle to be registered is less than that  
10 represented by the license to be transferred.

11 (c) The owner or lessee shall pay any additional fee which shall be  
12 required under the registration laws of this state.

13 (d) The owner shall endorse an assignment and warranty of title upon  
14 the certificate of title for the vehicle, and he shall deliver the certificate  
15 of title to the purchaser or transferee at the time of delivering the vehicle,  
16 except as provided in §§ 27-14-906 and 27-14-909."

18 SECTION 2. Arkansas Code § 27-14-1012(b), regarding the registration or  
19 renewal of motor vehicle license plates, is amended to read as follows:

20 "(b) ~~Sixty (60)~~ Not less than thirty (30) days before the expiration of  
21 the license, the director shall notify the owner of a registered motor vehicle  
22 subject to this subchapter at the last address of the owner of the motor  
23 vehicle as such owner's name and address appear on the records of the Office  
24 of Motor Vehicle, but the director is not required to go beyond the face of  
25 the last registration statement."  
26

27 SECTION 3. All provisions of this act of a general and permanent nature  
28 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
29 Revision Commission shall incorporate the same in the Code.  
30

31 SECTION 4. If any provision of this act or the application thereof to  
32 any person or circumstance is held invalid, such invalidity shall not affect  
33 other provisions or applications of the act which can be given effect without  
34 the invalid provision or application, and to this end the provisions of this  
35 act are declared to be severable.

1           SECTION 5. All laws and parts of laws in conflict with this act are  
2 hereby repealed.
