9 AN ACT TO AMEND THE ARKANSAS SEWAGE DISPOSAL
10 SYSTEMS ACT AS ADMINISTERED BY THE DEPARTMENT OF
11 HEALTH TO INCREASE FEES FOR INDIVIDUAL SEWAGE
12 DISPOSAL PERMIT APPLICATIONS AND SUBDIVISION
13 REVIEWS; AND FOR OTHER PURPOSES.

16 TO AMEND THE ARKANSAS SEWAGE DISPOSAL
17 SYSTEMS ACT AS ADMINISTERED BY THE
18 DEPARTMENT OF HEALTH TO INCREASE FEES
19 FOR INDIVIDUAL SEWAGE DISPOSAL PERMIT
20 APPLICATIONS AND SUBDIVISION REVIEWS.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code § 14-236-116(a), concerning fees for
26 individual sewage disposal permit applications is amended to read as follows:

27 (a)(1) A fee ~~of thirty dollars (\$30.00)~~ shall be levied for the review
28 of individual sewage disposal permit applications. ~~However, it shall not be~~
29 ~~necessary to pay an additional fee to obtain a permit to repair an individual~~
30 ~~sewage disposal system or alternate and experimental system installed under a~~
31 ~~permit for which a fee has been paid under the provisions of this chapter, as~~
32 follows:

33 (A) For structures one thousand five hundred square feet
34 (1,500 sq. ft.) or less, the fee to review a permit application is thirty
35 dollars (\$30.00);



1 (B) For structures over one thousand five hundred square
 2 feet (1,500 sq. ft.) and less than two thousand square feet (2,000 sq. ft.),
 3 the fee to review a permit application is forty-five dollars (\$45.00);

4 (C) For structures over two thousand square feet (2,000 sq.
 5 ft.) and less than three thousand square feet (3,000 sq. ft.), the fee to
 6 review a permit application is ninety dollars (\$90.00);

7 (D) For structures over three thousand square feet (3,000
 8 sq. ft.) and less than four thousand square feet (4,000 sq. ft.), the fee to
 9 review a permit application is one hundred and twenty dollars (\$120.00);

10 (E) For structures four thousand square feet (4,000) and
 11 over, the fee to review a permit application is one hundred and fifty dollars
 12 (\$150.00); and

13 (F) For the alteration, repair, or extension of any
 14 individual sewage disposal system, the fee to review a permit application is
 15 fifty dollars (\$50.00).

16 (2)(A) In calculating the square footage of a residential
 17 structure for purposes of determining the applicable fee under this section,
 18 the square footage of all auxiliary areas of the residential structure shall
 19 not be considered.

20 (B) Auxiliary areas include garages, carports, porches and
 21 other similar areas as determined by the Division of Sanitarian Services of
 22 the Department of Health.

 24 SECTION 2. Arkansas Code § 14-236-116(e) concerning fees for review
 25 certificates for sewage permits is amended to read as follows:

26 (e) The fee for the issuance of a review certificate under the
 27 provisions of this chapter to the person developing a subdivision shall be a
 28 minimum of ~~thirty dollars (\$30.00)~~ one hundred dollars (\$100) for one (1) lot
 29 and ~~five dollars (\$5.00)~~ twenty-five dollars (\$25.00) for each following lot,
 30 with a maximum of ~~five hundred dollars (\$500)~~ one thousand five hundred
 31 dollars (\$1,500).
