23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 27-24-1305(c), regarding the special
26 license plate for United States Armed Forces retired service members, is
27 amended to read as follows:

28 (c)(1) A retired member of the armed forces may apply for and annually
29 renew a special license plate issued under this section.

30 (2) The fee for the initial application for a special license
31 plate under this section is+

32 ~~(A) The the~~ fee required by law for the registration and
33 licensing of the motor vehicle; ~~and~~

34 ~~(B) A handling and administrative fee in the amount of ten~~
35 ~~dollars (\$10.00).~~



1 (3) The fee for the renewal of a special license plate under
2 this section is the fee required by law for the registration and licensing of
3 the motor vehicle.

4 (4) The replacement fee for a special license plate issued under
5 this section is ten dollars (\$10.00).

7 SECTION 2. Arkansas Code § 27-24-1305(e) and (f), regarding the
8 special license plate for United States Armed Forces retired service members,
9 is amended to read as follows:

10 ~~(e)(1) The fee remitted under subdivision (e)(2)(B) of this section~~
11 ~~shall be deposited into the State Central Services Fund for the benefit of~~
12 ~~the Revenue Division of the Department of Finance and Administration.~~

13 ~~(2) The fee shall be credited as supplemental and in addition to~~
14 ~~all other funds as may be deposited for the benefit of the division.~~

15 ~~(3) The fee shall not be considered or credited to the division~~
16 ~~as direct revenue.~~

17 ~~(f)~~(e) The registration of a special license plate under this section
18 may:

19 (1) Continue from year to year as long as it is renewed each
20 year within the time and manner required by law; and

21 (2) Be renewed as provided under §§ 27-14-1012 and 27-14-1013.
