19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code § 12-62-602 is amended to read as follows:
22 12-62-602. Definitions.

23 As used in this subchapter:

24 (1) "Approved institution" means an Arkansas public or private
25 postsecondary institution that is accredited or has achieved candidacy status
26 from the North Central Association Commission on Institutions of Higher
27 Education or is a technical institute or comprehensive lifelong learning
28 center under the supervision of the Department of Workforce Education;

29 (2) "Critical military occupation specialty or Air Force skill
30 code" means a military occupation specialty or skill code that has been
31 designated as critical by the Adjutant General, based upon:

32 (A) The mobilization priority of the unit;

33 (B) The difficulty of attracting, qualifying, and filling
34 the specialty;

35 (C) The ability to maintain acceptable strength levels



1 within the specialty; and

2 (D) Such other factors as the Adjutant General may deem
3 appropriate;

4 (3)(A) “Eligible ~~recruit~~ service member” means both nonprior
5 service persons and prior service persons who are otherwise qualified to
6 enlist in the Arkansas National Guard and who are enlisting in a critical
7 military occupation specialty or Air Force skill code and who have ten (10)
8 years’ service or less; ~~and.~~

9 (B) ~~In-service recruits are not eligible~~ “Eligible service
10 member” does not include an in-service recruit;

11 (4) “Qualified applicant” means an eligible ~~recruit~~ service
12 member who:

13 (A) Has met all requirements for enlistment and has
14 enlisted in a critical military occupation specialty or Air Force skill code;

15 (B) Has a sufficient score to be rated as category IIIA or
16 higher based upon scores on standard military tests (score of 50 or higher on
17 the Armed Services Vocational Aptitude Battery or equivalent);

18 (C) Meets and continues to meet Good Soldier or Good
19 Airman criteria as set by the Adjutant General; and

20 (D) Meets the current scholastic criteria of and is
21 currently enrolled as a full-time student in good standing at an approved
22 institution.

23

24 SECTION 2. Arkansas Code § 12-62-603 is amended to read as follows:

25 12-62-603. Established – Eligibility.

26 (a)(1) There is ~~hereby~~ established for qualified applicants an
27 Arkansas National Guard Tuition Incentive Program, which shall consist of a
28 ~~one-time~~ an annual tuition incentive award of up to ~~one thousand dollars~~
29 ~~(\$1,000)~~ five thousand dollars (\$5,000) per eligible ~~recruit~~ service member,
30 payable at ~~five hundred dollars (\$500)~~ two thousand five hundred dollars
31 (\$2,500) per semester for two (2) semesters, with payments made directly to
32 the approved institution.

33 (2) ~~Awards~~ The number of tuition incentive awards shall be
34 limited to ~~a maximum of three hundred (300) recruits per calendar year~~ the
35 fiscal year appropriation for the program.

36 (3) Tuition incentive awards must be used at an approved

1 institution.

2 (4) Tuition incentive awards are available only for payment
3 toward undergraduate studies at an approved institution.

4 (5) Eligible ~~recruits~~ service members ~~must~~ shall complete
5 military training and be awarded a military occupation specialty or Air Force
6 skill code before payment ~~may be~~ of a tuition incentive award is made.

7 (b) In order to be eligible for a second semester or subsequent
8 semester tuition incentive award, an eligible service member shall continue
9 as a student ~~must continue~~ in good standing at an approved institution and
10 ~~must~~ shall continue as a satisfactory participant in the Arkansas National
11 Guard, meeting Good Soldier or Good Airman requirements, as certified by his
12 or her unit commander.

13
14 SECTION 3. Arkansas Code § 12-62-605 is amended to read as follows:

15 12-62-605. ~~Regulations~~ Rules.

16 (a)(1) The Adjutant General shall establish, implement, and enforce
17 such administrative rules ~~and regulations~~ as are necessary for implementation
18 of the Arkansas National Guard Tuition Incentive Program.

19 (2) The ~~regulations~~ rules shall include criteria for selection
20 from among applicants in those circumstances in which the number of
21 applicants exceeds ~~three hundred (300) per calendar year~~ the fiscal year
22 appropriation for the program.

23 (b) In establishing ~~regulations~~ rules relating to academic
24 qualification, certification, recertification, and payment, the Adjutant
25 General shall obtain the advice of the Department of Higher Education.

26
27 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
28 General Assembly of the State of Arkansas that since September 11, 2001, the
29 country has an increased need for soldiers to fight against terrorism,
30 domestic and abroad; that National Guard members risk their lives to protect
31 and defend our country; that there is a constant need for recruits; and this
32 act will immediately impact recruiting efforts by offering a tuition
33 incentive that is comparable to other states. Therefore, an emergency is
34 declared to exist and this act being immediately necessary for the
35 preservation of the public peace, health, and safety shall become effective
36 on:

(1) The date of its approval by the Governor;

(2) If the bill is neither approved nor vetoed by the Governor, the expiration of the period of time during which the Governor may veto the bill; or

(3) If the bill is vetoed by the Governor and the veto is overridden, the date the last house overrides the veto.
