7	Administrative Procedure Act, § 25-15-201 et seq.
8	(b) Except in the case of a person or entity obtaining a license or
9	course approval by false or fraudulent representation, the Arkansas Real
10	Estate Commission shall not investigate the actions of or conduct a
11	disciplinary hearing regarding a licensed school, administrator, or
12	instructor unless the complaint is filed or the investigation begins within
13	three (3) years from the date of the actions.
14	
15	SECTION 4. TEMPORARY LANGUAGE. DO NOT CODIFY. Effective January 1,
16	2014, the Arkansas Real Estate Commission has the authority to issue and
17	renew real estate education licenses under this subchapter. It is the intent
18	of this section to cure any gap in applicable law resulting from the
19	transition from licensing under prior law with the State Board of Private
20	Career Education to this subchapter.
