10 THE ARKANSAS CODE CONCERNING ENVIRONMENTAL LAW; AND

15 TO MAKE TECHNICAL CORRECTIONS TO TITLE 8
16 OF THE ARKANSAS CODE CONCERNING
17 ENVIRONMENTAL LAW.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 8-6-908(c), concerning waiver of
23 requirements for formal examinations of certain applicants for a license to
24 operate a solid waste management facility, is amended to read as follows to
25 correct an obsolete reference:

26 (c) The director may, at his or her discretion, waive the requirements
27 or any part of the requirements for formal examination of an applicant for a
28 license if the applicant holds a substantially equivalent solid waste
29 management facility operator's license issued by another state, territory, or
30 district of the United States in accordance with ~~§ 17-1-106 [repealed]~~ the
31 Arkansas Occupational Licensing of Uniformed Service Members, Veterans, and
32 Spouses Act of 2021, § 17-4-101 et seq.
33

34 SECTION 2. Arkansas Code § 8-9-703(8)-(9), concerning definitions of
35 "used, broken cathode ray tube" and "used, intact cathode ray tube" under the
36 Electronic Waste Collection, Recycling, and Reuse Act, are repealed because



1 the definitions are not used in the subchapter.

 3 ~~(8) "Used, broken cathode ray tube" means a cathode ray tube with~~
 4 ~~glass removed from its housing or casing whose vacuum has been released; and~~

5 ~~(9) "Used, intact cathode ray tube" means a cathode ray tube~~
 6 ~~whose vacuum has not been released.~~

 8 SECTION 3. Arkansas Code § 8-9-711(c)-(d), concerning reporting of
 9 collection of consumer electronic items under the Electronic Waste
 10 Collection, Recycling, and Reuse Act, is amended to read as follows to add
 11 clarifying language:

12 (c) The monthly report required under subsection (b) of this section
 13 shall include the location of collection, consumer electronic items
 14 collected, and per-pound accounting for each category of consumer electronic
 15 items collected.

16 (d) Within sixty (60) calendar days of submission of the final monthly
 17 report required under subsection (b) of this section for a calendar year, the
 18 contract administrator and the contractor shall prepare and publish an annual
 19 report based on the monthly reports required under subsection (b) of this
 20 section.

21
 22 SECTION 4. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.

23 It is the intent of the General Assembly that:

24 (1) The enactment and adoption of this act shall not expressly
 25 or impliedly repeal an act passed during the regular session of the Ninety-
 26 Fourth General Assembly;

27 (2) To the extent that a conflict exists between an act of the
 28 regular session of the Ninety-Fourth General Assembly and this act:

29 (A) The act of the regular session of the Ninety-Fourth
 30 General Assembly shall be treated as a subsequent act passed by the General
 31 Assembly for the purposes of:

32 (i) Giving the act of the regular session of the
 33 Ninety-Fourth General Assembly its full force and effect; and

34 (ii) Amending or repealing the appropriate parts of
 35 the Arkansas Code of 1987; and

36 (B) Section 1-2-107 shall not apply; and

1 (3) This act shall make only technical, not substantive, changes
2 to the Arkansas Code of 1987.
