## **Subtitle of House Bill 1180**

TO CREATE THE BABY OLIVIA ACT.

## Amendment No. 1 to House Bill 1180

Amend House Bill 1180 as engrossed H2/5/25 (version: 2/5/25 09:07:21 AM):

Page 1, line 28, delete "human" and substitute "human fetal"

AND

Page 1, line 35, delete "Human" and substitute "Human fetal"

AND

Page 1, line 36, delete "human" and substitute "human fetal"

AND

Page 2, line 5, delete "human" and substitute "human fetal"

AND

Page 2, line 6, delete "fifth" and substitute "sixth"

AND

Page 2, delete lines 7 through 15, and substitute the following:

"(2)(A) The human fetal growth and development discussion required by subdivision (b)(1) of this section shall include:

- (i) A high-definition ultrasound video that shows the brain, heart, sex organs, and other vital organs in early fetal development; and
- (ii) A video that is at least three (3) minutes in duration that depicts the process of fertilization and every stage of human development inside the uterus and notes significant markers in cell growth and organ development for every significant marker of pregnancy until birth.
- (B) The Division of Elementary and Secondary Education shall promulgate a rule for a list of approved videos under subdivision (b)(2)(A) of this section, including without limitation the "Meet Baby Olivia" video developed by Live Action, as it existed on January 1, 2025."

AND

- Page 2, delete lines 17 through 20, and substitute the following:
- "SECTION 3. Arkansas Code § 6-18-703(a), concerning the establishment of school-based health clinics by school districts, is amended to read as follows:
- (a)(1)(A)(i) No school-based health clinic may be established in a public school until requested by resolution by the school district board of directors, and no child shall receive school-based health clinic services without parental consent.
- (ii) Parental consent to contraceptive services and condom distribution shall be specific, in writing, and maintained in the student's health records.
- (B)(i) All school-based clinics shall maintain accurate records of the distributing and prescribing of contraceptives and condoms.
- (ii) The number of pregnancies and sexually transmitted diseases among students in the schools with school-based clinics shall be transmitted annually to the school district board of directors.
- (iii) Records maintained under this section are part of the confidential medical record of the student.
- (iv) Numerical or statistical data required to be maintained under this subsection may not be released in a manner that reveals the identity of or any other information contained in the file of the student.

- (2) If the board of directors establishes a school-based health clinic, the board of directors shall retain absolute control over the operations and programs offered by the clinic.
  - (3)(A) Schools that offer sex education in school-based health"
