SPECIAL LANGUAGE REVISIONS

Stipends. This language was changed to increase the number of housestaff from 645 to 673 for FY2020, an increase of 28 positions. The maximum annual stipend for interns was also increased \$890 to \$53,341.

Establishment of a "Growth Pool." This language was changed to have the Arkansas Department of Higher Education, rather than the Office of Personnel Management (OPM), establish and maintain the 300 position growth pool for UAMS. Additionally, UAMS must provide justification to the Department of Higher Education to use the growth pool - formerly OPM handled these duties, respectively.

New Special Language Funding Transfer NCI Designation Trust Fund. This language allows the Chief Fiscal Officer of the State to transfer funds to the National Cancer Institute Designation Trust Fund from the State Treasurer and Auditor of State funds from the University of Arkansas Medical Center Fund or from cash funds of UAMS at the request of Chancellor of UAMS. The funding level must be deemed sufficient by the CFO and have been reviewed by ALC.
