PRICING APPROACH AND COMMENTS

House Bill 1142 creates the Reproductive Empowerment and Support Through Optimal Restoration (RESTORE) Act. The bill requires health plans to cover procedures associated with natural procreative technology and restorative reproductive medicine (RRM) including examinations, ultrasounds, blood tests, hormone panel tests, surgeries to reconstruct the uterus, fallopian tubes, ovaries, and other organ structures, to eliminate endometriosis and other reproductive health conditions.

It is not clear whether HB1142 would apply to EBD as it is an amendment to the existing Arkansas Code § 23-85-137 that requires IVF coverage, but this requirement does not apply to self-insured plans. However, are projecting the financial impact as if the bill would apply to EBD.

The costs of RRM can vary based on the specific treatments and services required, below are some examples:

Treatment	Price Low	Price High
Initial Consultation & Diagnostic	\$200	\$500
Hormonal Therapies	\$50	\$200
Surgical Procedures	\$3,000	\$10,000
Fertility Charting	\$100	\$300
Lifestyle Coaching	\$50	\$200

After accounting for service mix, member cost sharing, and other research, the annual cost for RRM to the plan is expected to fall between \$800 and \$1,600 per utilizer.

Since RRM is relatively new to the insurance market, utilization data is limited. Research suggested utilization was expected to be less than IVF. Thus, we leveraged our IVF projected utilization rate (0.5% of women childbearing age) as the basis for the RRM projection. We



projected a range of 60 - 180 potential utilizers of RRM services on EBD's plans annually. This could increase over time as this therapy becomes more available.

Overall cost to EBD is projected to fall within the range of \$50,000 to \$300,000. If IVF were covered, as required by Arkansas Code § 23-85-137, some of the costs would be offset by reduction in IVF utilization.
