**JOBS ACT OF 2021:** Language governs appropriation transfer to various state agencies. Requires review by Performance Evaluation and Expenditure Review Subcommittee along with a monthly report submitted by the Chief Fiscal Officer of the State.

### TRANSFER PROCEDURES - APPROPRIATION - AMERICAN RESCUE PLAN ACT OF

**2021:** Language governs appropriation transfer to various state agencies. Requires review by Performance Evaluation and Expenditure Review Subcommittee along with a monthly report submitted by the Chief Fiscal Officer of the State.

**TRANSFER PROCEDURES - PERSONAL SERVICES**-AND REGULAR SALARIES: Language governs appropriation transfer to various state agencies. Requires review by Performance Evaluation and Expenditure Review Subcommittee.

**FUNDING TRANSFER - PERFORMANCE FUND:** Funding of state agencies supported by General Revenues for salary increases, personal services, cost of living adjustments and higher ed. institutions shall be provided for by a transfer from the Performance Fund (MAJ).

**PREGNANCY HELP ORGANIZATION GRANTS:** Defines "pregnancy help organization" and disbursement of grant funds through the Department of Finance and Administration. DFA will also be responsible for promulgating rules and reporting each fiscal year to the Legislative Council or Joint Budget Committee.
