2	(2) "Approved program" means a program for the education and
3	training of anesthesiologist assistants approved by the Arkansas State
4	Medical Board; and
5	(3) "Direct supervision" means the on-site, personal supervision
6	by an anesthesiologist who is:
7	(A) Present in the office or surgical or obstetrical suite
8	when a procedure is being performed in the office or surgical or obstetrical
9	suite; and
10	(B) In all instances immediately available to provide
11	assistance and direction to the anesthesiologist assistant while anesthesia
12	services are being performed.
13	
14	17-95-1203. Arkansas State Medical Board — Powers and duties under
15	subchapter.
16	(a) The Arkansas State Medical Board shall:
17	(1) License and renew the licenses of qualified applicants under
18	this subchapter;
19	(2)(A) Maintain a current list of every person licensed to
20	practice under this subchapter.
21	(B) The list under subdivision (a)(2)(A) of this section
22	shall show:
23	(i) The licensee's last known place of residence;
24	<u>and</u>
25	(ii) The date and number of the license;
26	(3) Prosecute persons who violate this subchapter and incur
27	necessary expenses of the prosecution;
28	(4) Keep a record of all proceedings of the board under this
29	subchapter and make the record available to the public for inspection during
30	reasonable business hours;
31	(5) Conduct hearings regarding discipline of a licensee under
32	this subchapter or denial, revocation, or suspension of a license under this
33	subchapter; and
34	(6)(A) Share information on a case-by-case basis of a person
35	whose license has been suspended, revoked, or denied under this subchapter.
36	(B) The information under subdivision (a)(6)(A) of this

1	section shall include:
2	(i) The name of the person whose license has been
3	suspended, revoked, or denied;
4	(ii) The type and cause of the action;
5	(iii) The date upon which a penalty is imposed;
6	(iv) The type of penalty imposed; or
7	(v) The duration of the penalty imposed.
8	(C) The information under subdivision (a)(6)(A) of this
9	section shall be available for public inspection during reasonable business
10	hours and shall be supplied to licensing entities in other states upon
11	request.
12	(b) The board may:
13	(1) Promulgate rules as necessary to enforce this subchapter
14	consistent with state law;
15	(2) Employ personnel as necessary to assist the board in
16	performing its duties under this subchapter;
17	(3) Establish license renewal requirements and procedures under
18	this subchapter as deemed appropriate by the board;
19	(4)(A) Secure the services of resource consultants as deemed
20	necessary by the board in performing its duties under this subchapter.
21	(B) The board shall reimburse resource consultants for all
22	actual and necessary expenses incurred while engaged in consultative service
23	to the board; and
24	(5) Establish license examination fees under this subchapter by
25	rule.

27	17-95-1204. Licensing.
28	(a) A person applying for licensure as an anesthesiologist assistant
29	under this subchapter shall submit an application to the Arkansas State
30	Medical Board on forms approved by the board.
31	(b) An application under this section is not effective for more than
32	one (1) year from the date of the original submission of the application and
33	fee, after which time an applicant shall submit to the board a new
34	application and fee.
35	(c) To qualify for licensure under this subchapter, an applicant under
36	this section shall:

1	(1)(A) Obtain a passing score on the examination administered
2	through the National Commission for Certification of Anesthesiologist
3	Assistants.
4	(B) A passing score under subdivision (c)(1)(A) of this
5	section shall be established by the National Commission for Certification of
6	Anesthesiologist Assistants; and
7	(2) Be certified in advanced cardiac life support.
8	
9	17-95-1205. Supervisory relationship.
10	(a) An anesthesiologist or anesthesiologist group, upon entering into
11	a supervisory relationship with a licensed anesthesiologist assistant, shall
12	file with the Arkansas State Medical Board a written protocol, including
13	without limitation:
14	(1) The name, address, and license number of the
15	anesthesiologist assistant;
16	(2) The name, address, license number, and United States Drug
17	Enforcement Administration registration number of each anesthesiologist who
18	will supervise the anesthesiologist assistant;
19	(3) The address of the anesthesiologist assistant's primary
20	practice location where the anesthesiologist assistant may practice;
21	(4) The date the protocol was developed and the date of all
22	revisions;
23	(5) The designation and signature of the primary supervising
24	anesthesiologist;
25	(6) The signatures of the anesthesiologist assistant and all
26	supervising anesthesiologists;
27	(7) The duties and functions of the anesthesiologist assistant;
28	(8) The conditions or procedures that require the provision of
29	care by a supervising anesthesiologist; and
30	(9) The procedures to be followed in the event of an anesthetic
31	emergency.
32	(b) The protocol required under subsection (a) of this section shall
33	$\underline{\text{be filed with the board before the anesthesiologist assistant begins practice}$
34	with the supervising anesthesiologist or anesthesiology group.
35	(c) An anesthesiologist assistant may perform the following duties
36	under the direct supervision of an anesthesiologist:

1	(1) Obtain a comprehensive patient history and present the
2	history to the supervising anesthesiologist;
3	(2) Pretest and calibrate anesthesia delivery systems and
4	monitor, obtain, and interpret information from the anesthesia delivery
5	<pre>systems;</pre>
6	(3) Assist the supervising anesthesiologist with implementation
7	of monitoring techniques;
8	(4) Establish basic and advanced airway interventions, including
9	intubations of the trachea and performance of ventilator support;
10	(5) Administer intermittent vasoactive drugs and start and
11	adjust vasoactive infusions;
12	(6) Administer anesthetic drugs, adjuvant drugs, and accessory
13	drugs;
14	(7) Perform epidural anesthetic procedures and spinal anesthetic
15	procedures;
16	(8) Administer blood, blood products, and supportive fluids;
17	(9) Support life functions during the administration of
18	anesthesia, including without limitation induction and intubation procedures,
19	the use of appropriate mechanical supportive devices, and the management of
20	fluids, electrolytes, and blood component balances;
21	(10) Recognize and take appropriate corrective action for
22	abnormal patient responses to anesthesia, adjunctive medication, or other
23	forms of therapy;
24	(11) Participate in management of the patient while in the post-
25	anesthesia recovery area, including the administration of supporting fluids;
26	<u>and</u>
27	(12) Place special peripheral and central venous and arterial
28	lines for blood sampling and monitoring as appropriate.
29	(d)(l) The supervising anesthesiologist shall delegate only tasks and
30	procedures to the anesthesiologist assistant that are within the supervising
31	anesthesiologist's scope of practice.
32	(2) The anesthesiologist assistant may work in any setting that
33	is within the scope of practice of the supervising anesthesiologist's
34	practice.
35	(e) Continuity of supervision in practice settings requires the
36	anacthecialogist assistant to document in the anacthesia record any change in

1	supervising anesthesiologist.
2	(f) The tasks and procedures performed by the anesthesiologist
3	assistant shall be documented in the appropriate medical record.
