19	TO EXPAND ELIGIBILITY FOR COVERAGE UNDER
20	THE STATE AND PUBLIC SCHOOL LIFE AND
21	HEALTH INSURANCE PROGRAM TO CERTAIN
22	VOLUNTEER FIREFIGHTERS.
23	
24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Arkansas Code § 21-5-407, concerning definitions used under
27	the State and Public School Life and Health Insurance Program, is amended to
28	add an additional subdivision to read as follows:
29	(21)(A) "Fire department" means an organization that:
30	(i) Is established for the prevention or
31	extinguishment of fires; and
32	(ii) Employs a volunteer fire fighter.
33	(B) "Fire department" includes a firefighting unit; and
34	(22) "Volunteer firefighter" means a member of a fire department
35	who:
36	(A) Actively engages in fire suppression, rescue, pump

1	operation, or other firefighting activity; and
2	(B) Receives less than five thousand dollars (\$5,000) in
3	total compensation during the taxable year from the volunteer fire department
4	that the volunteer firefighter serves.
5	
6	SECTION 2. Arkansas Code § 21-5-410(g)(1), concerning eligibility to
7	participate in the State and Public School Life and Health Insurance Program,
8	is amended to read as follows:
9	(g)(l) The following persons are eligible to participate in the
10	program:
11	(A) A public school employee who is in a position that
12	requires on average at least thirty (30) hours per week of actual performance
13	of duty during the annual school year; and
14	(B) A full-time school bus driver who is employed by a
15	public school district to drive regular routes during the annual school year:
16	and
17	(C)(i) A volunteer firefighter.
18	(ii) A volunteer firefighter who elects to
19	participate in the program is responsible to pay a premium as determined by
20	the State Board of Finance or the cost of the policy issued to the volunteer
21	<u>firefighter.</u>
22	(iii) The volunteer firefighter portion of the
23	premium may be:
24	(a) Deducted from a bank account of the
25	volunteer firefighter to be paid by a monthly bank draft on the date
26	designated by the Employee Benefits Division; or
27	(b) Paid in full or partially by the fire
28	department that employs the volunteer firefighter directly to the division on
29	the date designated by the division.
