

State Fiscal Year is July 1, 2024 through June 30, 2025

Collections of Gross General Revenues year-to-date of approximately \$2,003.64 million have decreased \$54.2 million, or 2.6% below the \$2,057.82 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$1,735.3 million decreased \$41.6 million, or 2.3% from the \$1,776.86 million available for distribution in September 2023.
