RE: Joint Performance Review Committee Reporting Requirements for Act 276 of 2021

Senator Rice and Representative Wardlaw:

According to Arkansas Code Annotated § 25-1-106, as amended by Act 276 of 2021, no later than August 1 of each even-numbered year, each state board and commission shall provide the Joint Performance Review Committee (herein referred to as the "Committee") with a report of the regularly scheduled meeting dates for the state board or commission for the previous two (2) fiscal years, including the attendance record of each member and the number of meetings that were convened.

The Committee is required to report its findings and any recommendations concerning the constitutional board or commission to the Arkansas Legislative Council no later than December 1 of each even-numbered year and may draft legislation to implement the recommendations.

Findings:

During the previous reporting cycle in 2022, it was evident by the responses received that many state boards and commissions were unaware of Act 276 of 2021, and the additional reporting requirements. In 2023, the Bureau of Legislative Research conducted a survey of all state boards and

commissions to determine a definitive list of these entities. The Bureau of Legislative Research used this list to send notices of Act 276 of 2021, the reporting requirements and deadlines, and the point of contact to submit these reports to all state boards and commissions on the following dates: July 11, 2024, September 18, 2024, and September 24, 2024.

According to the 2023 survey results provided to the Bureau of Legislative Research, the following is noted:

- 1. There are approximately 272 state boards and commissions.
- 2. There are approximately 57 Arkansas Constitution Amendment 33 Entities, yet these entities are not required to submit an Act 276 of 2021 report.

Approximately 207 boards and commissions have complied, and 12 boards and commissions have not complied, with the requirements of Arkansas Code Annotated § 25-1-106. Many state boards and commissions were not included in this report due to being abolished or repealed due to prior passed legislation, falling under the definition of a "constitutional board or commission" by Arkansas Constitution Amendment 33, or not being required to submit an Act 276 of 2021 report. Attached is a list of Amendment 33 entities who have complied, a list of all other boards and commissions who have complied, and a list of those who have not complied with Act 276 of 2021. Following the August 1 reporting deadline, the Committee met on October 1, 2024, to discuss Act 276 of 2021. On October 21, 2024, the Committee met to adopt the final report of Act 276 of 2021 report submissions to be submitted to the Arkansas Legislative Council. The Committee did not recommend draft legislation to be included in this report.
