The Department's Office of School Choice and Parent Empowerment, within the Division of Elementary and Secondary Education, has administered the planning, implementation, and monitoring of Education Freedom Accounts while also overseeing the Department's efforts supporting school choice in Arkansas. Introduction

Report overview:

In accordance with **Ark. Code Ann. § 6-18-2510**, the Arkansas Department of Education presents this annual report regarding the implementation of Education Freedom Accounts (EFAs) to the Arkansas Legislative Council, as well as the House and Senate Committees on Education. This report covers the period from the launch of EFAs on June 19, 2023, through June 30, 2024.

As stipulated in Ark. Code Ann. § 6-18-2510, this report includes the following:

1. The total number of students currently participating in the program
2. A list of all participating schools and participating service providers
3. The total student enrollment of each participating school and the percentage of the total enrollment of each school represented by participating students

Introduction

Education Freedom Account overview:

For the 2023-2024 academic year, the Education Freedom Accounts (EFAs) were created to empower parents to make the best educational choice for their family by providing financial resources for eligible students to attend participating private schools. For the 2023-2024 school year, each EFA provided \$6,672 per student, with a higher allocation of \$7,413 for recipients of the 2022-2023 Succeed Scholarship. These funds were disbursed quarterly to families to fund their chosen educational options. All payments were processed through ClassWallet, a secure digital and accounts payable platform, ensuring that funds were delivered directly to participating schools and service providers for educational services and qualifying expenses.

To qualify for the 2023-2024 academic year, students must have been eligible to enroll in an Arkansas public elementary or secondary school, have a parent who is a current resident of the State, and meet one of the following criteria:

1. First time kindergarteners
2. Students coming from “F” schools or “Level 5” districts
3. Students who participated in the Succeed Scholarship Program for the 2022-2023 school year^{1,2}
4. Students with a disability identified under the Individuals with Disabilities Education Act
5. Students experiencing homelessness
6. Current or former foster care children
7. Children of active-duty military personnel

1. Per Ark. Code Ann. § 6-41-901, to qualify for the Succeed Scholarship Program, a student must have been enrolled in a public school district for at least the full school year immediately prior (or have a superintendent waiver) and (1) have a disability (as defined in the Individuals with Disabilities Education Act) or (2) have been a current or former foster care students or (3) have participated in the Succeed Scholarship program during the prior year and not turned twenty-one years of age or (4) Have been the child of a uniformed service member (if funds remain after all other eligible students received funding.

2. Former Succeed Scholarship students continue to receive the full foundation funding amount (which they received as part of the Succeed Scholarship Program)

Student participation

Overview

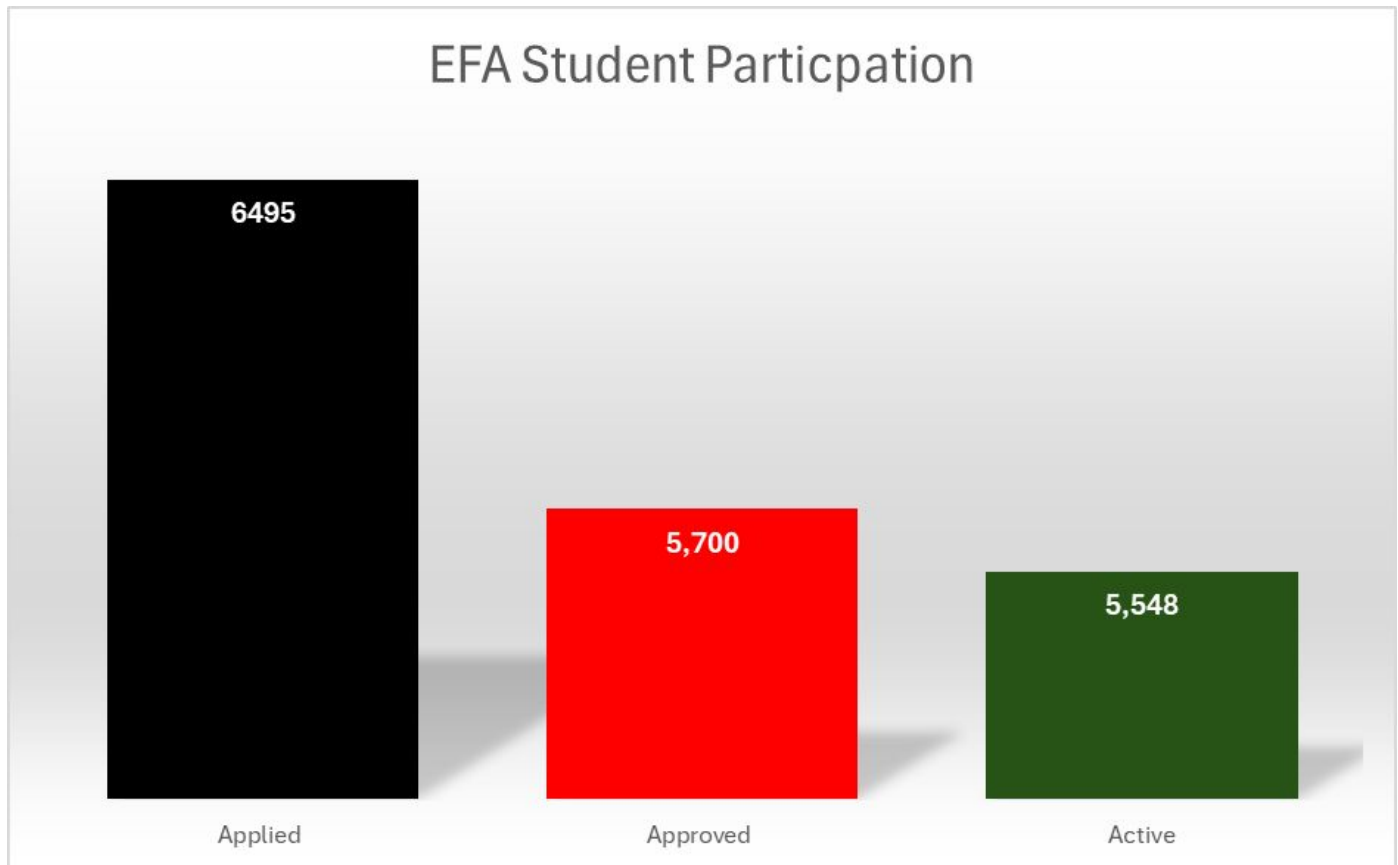
The program has received strong interest from Arkansas' families. There were 5,548 active Education Freedom Accounts funded during the 23-24 academic year. This rate of participation comes in spite of a delayed start and then restart after interruption due to litigation. Education Freedom Accounts did not launch until June 19th, 2023. Education Freedom Account participants display the following characteristics:

- 1. Eligibility criteria:** Students with disabilities, as identified under the Individuals with Disabilities Education Act (IDEA), represented the largest share of participating students, accounting for 57% of total participants. First-time kindergarteners also made up a significant portion, comprising 30% of the participant population. Of the previous year's 685 Succeed Scholarship Program participants, 630 received funds through an Education Freedom Account (EFA).
- 2. Prior public school enrollment status:** Approximately 18% (1,216) of the students who submitted an application were enrolled in the public school system during the 2022-2023 academic year.

EFA Participants by Eligibility Category

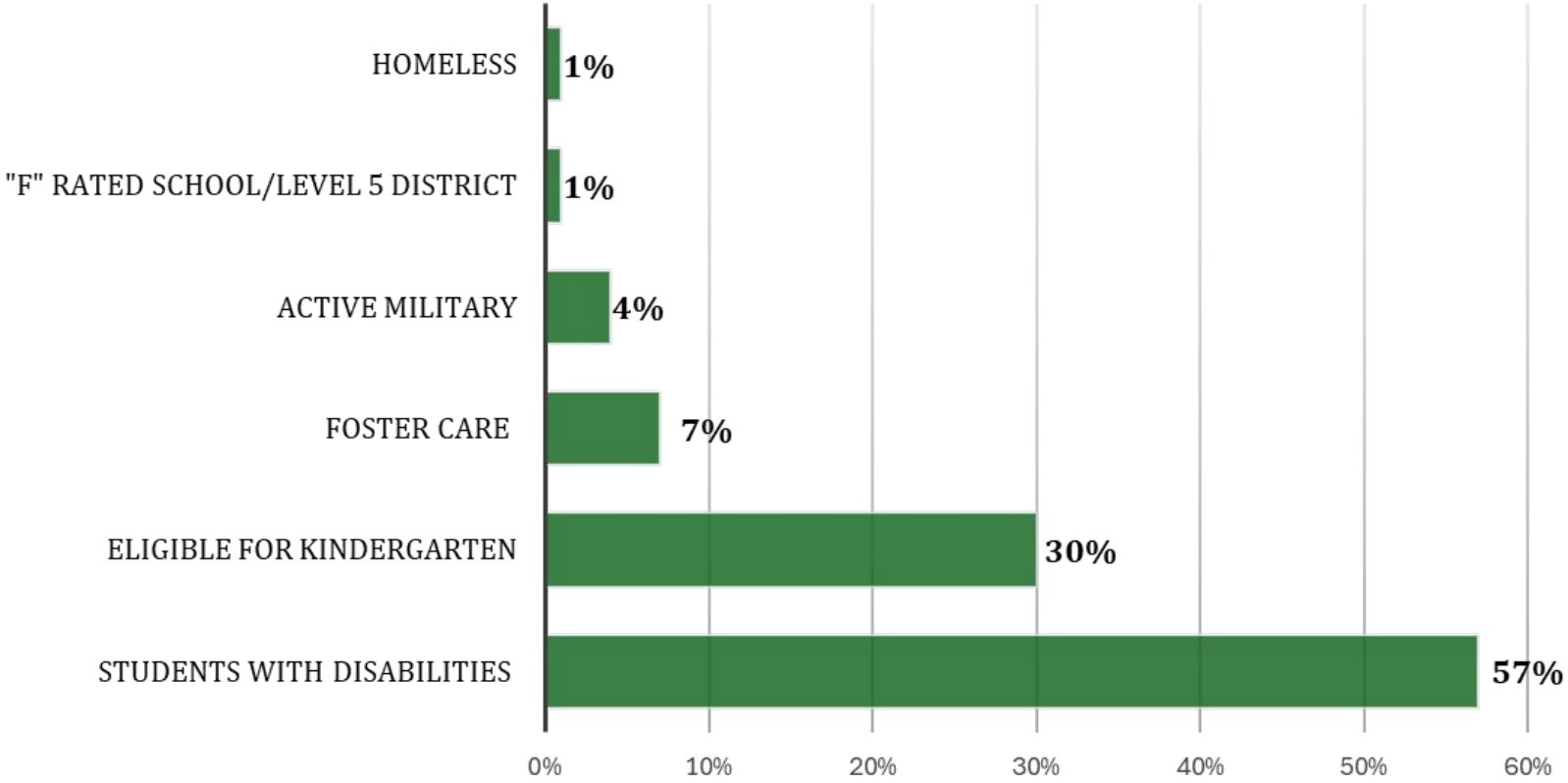
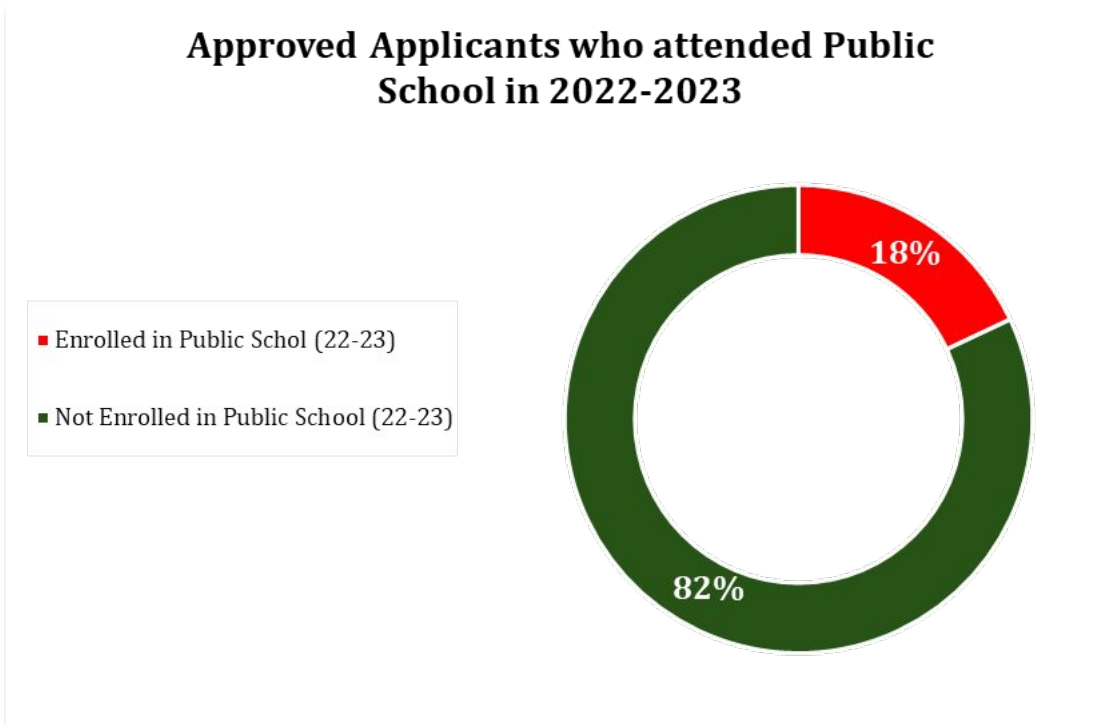


Figure 3: Participation, by previous school status during the 2022-2023 school year

Fiscal impact

Overview

We considered three questions concerning the fiscal impact of the 2023-2024 academic year Education Freedom Accounts program:

1. What is the total cost of the program to the state of Arkansas?
2. How are program funds spent?
3. What is the impact on the Arkansas education budget by student type?

Fiscal impact analysis

Program cost: \$34,925,391.56

Fund use:

For the 2023-2024 academic year, 93% of the Education Freedom Account (EFA) funds were used for tuition at participating private schools. Supplies and uniform purchases made up the remaining 4.6% of total cost for 2023-2024. Class Wallet transaction processing fees accounted for \$838,893.51 (2.4%). Among non-tuition and fee categories, school supplies were the most common expense for participating families.

Budget impact:

For the 2023-2024 academic year, the value of each participating student's Education Freedom Account (EFA), who had been enrolled in a private or public school during the prior year, was fully funded by the State, representing new State expenditures of \$6,672 per student. Students entering the EFA program from an Arkansas public school had a net-zero impact on the general fund.

Districts support a portion of Arkansas' per-pupil foundation funding amount through the State's 25 mill uniform property tax, AR Const Art 14 § 3. The State subsequently funds the difference between each district's property tax contribution and the full per-pupil foundation funding amount, which in 2022-2023 was \$7,413. The share of the per-pupil foundation funding amount covered by the State thus varies dramatically by district; for example, some districts entirely cover the per-pupil foundation funding amount through the 25 mill uniform property tax and do not require additional State funds.

When a student leaves an Arkansas public district in favor of a private school, the district will not receive the State-funded portion of the per-pupil foundation funding amount (but will keep local property tax funds, which will now be distributed over a smaller base of students). However, because funding amounts are set based on prior year enrollment counts, the earliest the impact could be felt if a student left their public district for the 2023-2024 school year is in the 2024-2025 school year. Even in that year, the state may support the district through Declining Enrollment Funding or other programs, and thus the full fiscal impact of the enrollment decline is not felt until 2025-2026.

Aggregate test data

In the first year of the Education Freedom Account (EFA) program, participating private schools were required to report the assessments administered to each participating student, including the results from those assessments (e.g., English Language Arts (ELA) and math scores, as well as national percentiles where applicable). Schools had the flexibility to choose from a wide range of assessments. The **NWEA Measure of Academic Progress (MAP)**, **Stanford 10**, **Iowa Test of Basic Skills**, and the **Classical Learning Test 10 (CLT10)** were among the most commonly used assessments by participating schools. Within a single school, multiple assessments could be used. Due to this flexibility and option to submit a portfolio of work or an alternate assessment for eligible students, aligned results were not available across all participating students.

For the 2023-2024 school year, program participation was limited to first-time kindergarteners, students from “F” schools or “Level 5” districts, students transitioning from the Succeed Scholarship Program, and specific special populations, including homeless students, current or former foster care students, students with disabilities, and children of active-duty military personnel. As noted previously, 87% of participants qualified for the program either as students with disabilities under IDEA (57%) or as first-time kindergarten students (30%).

For assessments that included a national percentile, EFA students were reported to average around the **50th percentile in both ELA and math**. This indicates that, on average, participating students scored higher than 50% of other students on nationally norm-referenced assessments.
