Senator Rice and Representative Wardlaw,

The Post-Prison Transfer Board actions report, as required by A.C.A. § 16-93-210, is submitted to the Legislative Council to show the number of persons who make application for parole or transfer to post-release supervision and those who are granted or denied during the prior month for each criminal offense classification. The report is required to include a breakdown by race, the reasons for denial, results of risk-needs assessment, and the course of action accompanying each denial.

The version of the report you are accustomed to receiving does not include reasons for denial, which is required by statute, but did include identifying information about offenders, which is not required by statute. This deficiency was discovered as part of a global review of publications and reports. The report that you received this month includes reasons for denial but does not include identifying information about specific offenders, including the result of risk assessments. As you know, the Department is transitioning to a new, validated risk assessment- the Ohio Risk Assessment System. This new system will provide evidence-based information to the Post Prison Transfer Board to assist with making release decisions.

In conjunction to adopting the ORAS, the Department is also working to create a new report, which provides a more streamlined and user-friendly display of the required information for public consumption. It is our hope to have a new version ready for the January report. I apologize for any confusion that these updates have caused and thank you for your patience while we create a report that not only meets statutory requirements, but also provides the legislature useful information on which to base policy decisions.
