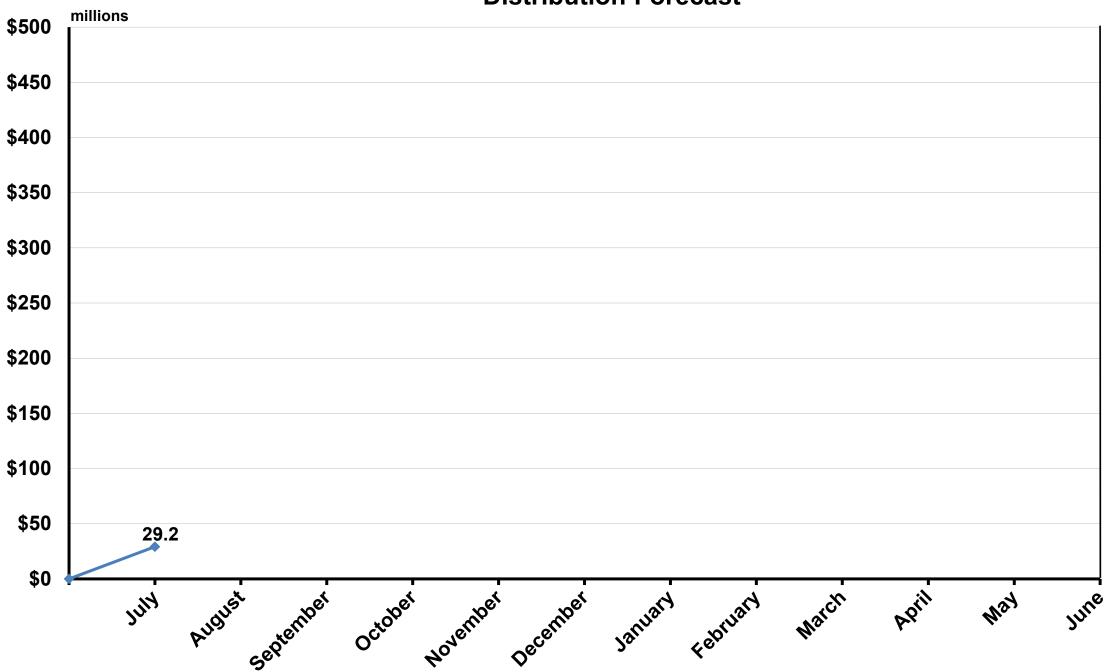
COMPARISON OF THE FIRST MONTH OF THE 2025-2026 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2024-2025 FISCAL YEAR

State Fiscal Year is July 1, 2025 through June 30, 2026

Collections of Gross General Revenues year-to-date of approximately \$636.82 million have increased \$21.0 million, or 3.4% above the \$615.79 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$557.5 million increased \$29.8 million, or 5.6% from the \$527.69 million available for distribution in July 2024.
