
## COMPARISON OF THE FIRST FIVE MONTHS OF THE 2025-2026 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2024-2025 FISCAL YEAR

State Fiscal Year is July 1, 2025 through June 30, 2026

Collections of Gross General Revenues year-to-date of approximately \$3.31 billion have increased \$58.9 million, or 1.8% above the \$3.25 billion collected last fiscal year-to-date. Net General Revenue Available for distribution of \$2.82 billion increased \$81.2 million, or 3.0% from the \$2.74 billion available for distribution in November 2024.
