We, the Executive Subcommittee of the Arkansas Legislative Council, met Tuesday, September 15, 2026, in Room B of the Big MAC Building, Little Rock, Arkansas. Senate Co-Chair Senator Justin Boyd called the meeting to order and saw a quorum of members present.

Co-Chair Boyd recognized Senator Missy Irvin to present Interim Resolution 2025-009, requesting that the Legislative Council show support for the habitat in the Prairie Pothole Region of the West-Central United States and urge the United States Fish and Wildlife Service to uphold robust setback rules that protect wetland and waterfowl populations. **After the presentation, Representative Jack Ladyman moved to recommend that Arkansas Legislative Council adopt Interim Resolution 2025-009. The motion was seconded and passed by voice vote. (Report Attachment 1)**

Co-Chair Boyd then recognized Ms. Marty Garrity, Director, Bureau of Legislative Research, to present other business. Ms. Garrity discussed authorization of payments of mileage and per diem to a member-elect of the General Assembly. **Representative Jack Ladyman moved that the Arkansas Legislative Council authorize payment of mileage and per diem to a member-elect of the General Assembly, following the general election or special election in which the member-elect successfully ran for office, for his or her attendance at interim committee meetings of the General Assembly or legislative task force meetings which members of the General Assembly are entitled to receive mileage and per diem. The motion was seconded and passed by voice vote.**

Director Garrity proceeded with informing the committee of the past October ALC week schedule and Co-Chair Eaves was recognized to give a statement. **Co-Chair Eaves stated, due to the fall budget hearing schedule the ALC Subcommittee meetings for October will be cancelled, with the exception of PEER, Review, and Administrative Rules, which may meet on Monday, October 12, and in the afternoon on Thursday, October 15. Matters normally submitted to the other subcommittees that have been determined by the ALC Co-chairs to have an imminent need such that they cannot wait until the November ALC Subcommittee meetings may be added to the calendar or taken up directly by the full ALC at its October 16 meeting. Agency imminent need requests for October should be submitted to the appropriate subcommittee staff, who will convey it to the ALC Co-chairs through Director Garrity. Reports and requests for action usually submitted for consideration by the full ALC should be provided to Director Garrity as usual.**

With no further business, the meeting was adjourned.

INTERIM RESOLUTION 2025-009

REQUESTING THAT THE LEGISLATIVE COUNCIL SHOW SUPPORT FOR THE
HABITAT IN THE PRAIRIE POTHOLE REGION OF THE WEST-CENTRAL UNITED
STATES AND URGE THE UNITED STATES FISH AND WILDLIFE SERVICE TO
UPHOLD ROBUST SETBACK RULES THAT PROTECT WETLAND AND WATERFOWL
POPULATIONS.

WHEREAS, the Prairie Pothole Region is the "Duck Factory" of North
America that produces more than half of the continent's migratory waterfowl
and supports critical breeding and feeding habitats for ducks and other
wildlife; and

WHEREAS, the United States continues to lose wetlands at an accelerated
pace across the Prairie Pothole Region, and any United States Fish and
Wildlife Service action should seek to minimize this rate of loss; and

WHEREAS, hunters, anglers, and conservationists have invested billions
of dollars in wildlife habitats through duck stamp purchases, hunting
licenses, and Pittman-Robertson Act funding, which has created one of
America's greatest conservation success stories; and

WHEREAS, the conservation value of these habitats cannot be overstated;
and

WHEREAS, since 1934, Federal Duck Stamp revenues, funding provided
primarily by generations of sportsmen and women, have conserved more than six
million (6,000,000) acres of habitat nationwide, including over one million
seven hundred thousand (1,700,000) acres protected by voluntary National
Wildlife Refuge System easements in the Prairie Pothole Region; and

WHEREAS, these lands form the core habitat base necessary for waterfowl
population resilience and recovery, and any action that facilitates wetland
drainage would disregard those investments and the promise that those duck
stamp funds be used to conserve critical waterfowl habitat in National
Wildlife Refuge System units and in easements that conserve wetlands and

1 grasslands in the Prairie Pothole Region; and

2
3 WHEREAS, with recent waterfowl populations on the brink of potential
4 restrictive seasons for more than one million (1,000,000) American duck
5 hunters, now is the time to be expanding and protecting conservation
6 investments, not weakening them; and

7
8 WHEREAS, the United States is facing a critical time for waterfowl
9 populations; and

10
11 WHEREAS, without the habitats conserved through these voluntary
12 easements, recent drought conditions could have caused greater impacts to
13 waterfowl populations and harvest opportunities by potentially requiring more
14 restrictive hunting regulations; and

15
16 WHEREAS, according to the 2025 Waterfowl Population Status Report, pond
17 counts in the Prairie Pothole Region dropped to four million two hundred
18 thousand (4,200,000), which is a nineteen percent (19%) reduction from 2024
19 and twenty percent (20%) below the long-term average; and

20
21 WHEREAS, because fifty percent (50%) to seventy-five percent (75%) of
22 North American Waterfowl are produced within the Prairie Pothole Region,
23 relying on these highly productive shallow wetlands for settling patterns,
24 breeding, brood rearing, and staging during migration, any degradation to
25 habitats reverberates nationwide; and

26
27 WHEREAS, notably, mallard populations sit at under six million six
28 hundred thousand (6,600,000), which is seventeen percent (17%) below the
29 long-term average and forty-four percent (44%) lower than just a decade ago;
30 and

31
32 WHEREAS, blue-winged teal populations have fallen to their lowest
33 levels since the early 2000s, necessitating reduced season lengths during the
34 September early teal season; and

35
36 WHEREAS, as a leading state in duck harvest, Arkansas recognizes the

1 link between the quality of breeding habitat in the Prairie Pothole Region
2 for continental duck populations and hunting seasons for Arkansas waterfowl
3 hunters; and
4

5 WHEREAS, conserving these essential habitats is imperative not only for
6 sustaining the population but also for safeguarding this heritage for future
7 generations; and
8

9 WHEREAS, compromising the hydrologic integrity of wetland easements
10 will further suppress annual fall flights, directly impacting the future of
11 waterfowl hunting and harming rural economies dependent on outdoor
12 recreation; and
13

14 WHEREAS, in Arkansas alone, duck hunters contribute over three hundred
15 million dollars (\$300,000,000) to the state's economy annually; and
16

17 WHEREAS, the current United States Fish and Wildlife Service rule
18 regarding drain tile setbacks upholds the integrity of voluntary easement
19 contracts by preventing the drainage of protected wetlands, provides
20 landowners with individualized setback plans, and offers safe harbor to
21 landowners who implement them; and
22

23 WHEREAS, if the current rule is not kept in place, the door is open for
24 potential drainage of National Wildlife Refuge System easements that protect
25 our hunting heritage; and
26

27 WHEREAS, once these wetlands are lost, our waterfowl and our hunting
28 heritage are lost as well; and
29

30 WHEREAS, the United States Fish and Wildlife Service should maintain
31 the sixty (60) years of precedent and uphold its commitment to protecting
32 publicly funded, voluntary conservation easements, critical wildlife habitat,
33 and America's outdoor traditions by keeping this rule in place; and
34

35 WHEREAS, for generations, hunters and conservationists have invested
36 heavily in the National Wildlife Refuge System to sustain migratory waterfowl

1 populations and preserve America's hunting heritage; and

2
3 WHEREAS, given the indispensable relationship between waterfowl
4 conservation efforts and hunting opportunities, we strongly urge the United
5 States Fish and Wildlife Service to ensure any regulatory, management, or
6 administrative action does not cause any degradation, fragmentation, or loss
7 of habitat on these publicly funded, voluntary conservation easements,

8
9 NOW THEREFORE,

10 BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE NINETY-FIFTH GENERAL
11 ASSEMBLY OF THE STATE OF ARKANSAS:

12
13 THAT the Legislative Council show support for the habitat in the
14 Prairie Pothole Region of the west-central United States and urge the United
15 States Fish and Wildlife Service to uphold robust, science-based setback
16 rules to steward these investments, protect both wetland hydrology and
17 waterfowl populations, and support rural economies for generations to come.

18
19 BE IT FURTHER RESOLVED THAT upon adoption of this resolution, a copy of this
20 resolution be provided to the Secretary of the Department of the Interior and
21 the Director of the United States Fish and Wildlife Service.
