## CURRENT SPECIAL LANGUAGE (WITH AGENCY REQUEST)

The Arkansas State Game and Fish Commission is hereby authorized to purchase from the Maintenance & General Operation Classifications in the Operations Appropriation provided by this Act for promotional items in an amount not to exceed fifty thousand dollars (\$50,000), as authorized by the Director of the Commission to meet fish and wildlife conservation and education needs.

The provisions of this section shall be in effect only from July 1, 2019 through June 30, 2020.
