ARKANSAS FORESTRY COMMISSION January 2019 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During January a total of 14 wildfires were suppressed for a total of 82 acres burned. Ten-year average for the month of January is 126 wildfires for 1795 acres burned.

Search and Rescue Assistance: Five Arkansas Forestry Commission (AFC) rangers assisted in a search and rescue for an elderly man around Highway 70 in the Glenwood area in Pike County.

Two AFC rangers assisted in a search and rescue for a couple that had been riding an ATV and became lost in the US National Forest. This was in the north part of Crawford County just a few miles southwest of Devil's Den State Park.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans, secures firefighting and emergency service equipment from the federal government, and administers a federal grant to assist approximately 1,000 fire departments. The RFP shop provides maintenance to property destined for FD's and repairs AFC equipment.

January 2019

- 51 fire departments, (147 firefighters), were provided wildland fire training.
- RFP received two brush trucks (valued at \$44,752.00) and three Freightliner trucks (valued at \$464,806.00)
- There were six Department of Defense (DOD) vehicles issued to FDs, four Freightliners (valued at \$664,892.00), two brush trucks (valued at \$146,267.33), as well as two generators (valued at \$63,077.00) and one hydro pressure cleaner (valued at \$11,863.58)
- There was one conex box (valued at \$11,900.00) issued to AFC's D7/White Co. office.
- 175 DOD Recycling Control Point (RCP) items were received for redistribution to FDs and AFC (valued at \$74,404.16) to include, hand warmers, sleeping bags, small diesel generators and hydraulic hand jacks.

- The RFP shop completed maintenance on ten AFC vehicles and equipment as well as five DOD vehicles.
- RFP provided two interest free loans via the Rural Fire Revolving Loan Fund.

- 2018 VFA Grant: Purchase order was issued for remaining personal protective equipment (PPE) order. Expected delivery sometime in the latter part of March.
- 2019 Annual Rural Fire Show: Vendors that attended last year's fire show have been invited to this year's event. Registration packets have been emailed.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas has 77 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in **January**:

- Delivered one initial program training
- Met with two communities to discuss returning to the program
- Presented one community with National Recognition trophy and signage
- Assisted one community with paperwork
- Attended Forestry Day at Capitol
- Delivered program overview and update to D2 personnel

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. AFC Investigators and district law enforcement officers opened one AFC property, one agency assist, fourteen dumping, one fire related and eight timber theft cases. They closed eleven dumping and four timber theft cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or

Arkansas Game and Fish Commission (AGFC) private lands wildlife biologists, and United States Department of Agriculture (USDA) Natural Resource Conservation Service soil and water professionals. Arkansas has 393,995 acres of private land actively enrolled in the Forest Stewardship Program. Landowners that implement practices under their FSP management plans become Certified Forest Stewards. There are 1,239 Forest Stewards owning 277,677 acres in the State.

For January, eleven FSP plans were prepared on 1,440 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 50 forest management practice plans on 3,473 acres. AFC personnel conducted four prescribed burns on 90 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

January 2019

- Reviewed Tree City USA applications and assisted several communities with the recertification process.
- Attended the Arkansas Municipal League winter conference and manned a booth providing information about AFC services to communities.
- Attended the Southern Group of State Foresters (SGSF) Urban & Community Forestry Committee winter meeting in GA.
- Met with community leaders in Clinton, Hardy, Pine Bluff and Mammoth Springs to provide guidance on their Tree City USA programs.
- Wrote article for the Arkansas Municipal League City & Town magazine on pruning trees.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- Staff trained 30 AFC field technicians with the Insect and Disease Recognition Course. This is a requirement of Ranger IIs.
- Staff attended the Southern Group of State Foresters, Forest Health Committee in Savannah, GA. This annual meeting helps states plan their forest health activities for the new calendar year. It also encourages collaborative forest health projects.
- At the meeting staff aided a committee to develop a new process for the Southern Pine Beetle (SPB) Detection Survey. This will result in faster trap data submission through Survey123 and faster SPB risk analysis for the entire southern region.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

With assistance from District 5, staff collected data from 1,000 trees at the Donaldson progeny test.

Staff gave presentation on tree improvement and nursery to the Central Arkansas Master Naturalists on 1-17-19 at the Witt Stephens Central Arkansas Nature Center. There were 50 in attendance.

Staff met Fred Raley, Director of Western Gulf Forest Tree Improvement Program and two members of his staff at Baucum Nursery and developed maps for thinning the cherrybark oak progeny tests in preparation for seed production areas.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15, through January 31st, there were 587 online orders and 125 traditional orders. Total sales of 1,098,145 pine and 5,935,675 hardwood. Comparatively, in the same period in FY 18, there were 636 online orders and 158 traditional orders. Total sales of 1,238,725 pine and 5,083,736 hardwood.

Baucum Nursery staff completed the following during the month of January:

- Lifted and packed the following:
 - o 331,500 pine
 - o 2,618,975 hardwood
 - Total seedlings packed = 2,950,475
- Shipped the following:
 - o 2,876,125 hardwood
 - o 255,825 pine
- Began removing rogue trees in improved cherrybark orchard.
- Installed new front gate and fence.
- Planted 1,000 lbs of black walnut for 2020 crop.

Tree Improvement:

During the month of January, the Bluff City Tree Improvement staff completed the following:

- Pruned lower limbs in orchard 1714.
- Planted new grafts in orchard 1718.

- Bush hogged progeny test at Donaldson.
- Bush hogged David Barr progeny test.
- Moved 1,500 pine rootstock into greenhouse for grafting.
- Completed inventory for production orchards.
- Began cutting scion material for grafting.

Best Management Practices (BMP): AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

BMP achieved the following in January 2019:

- Compiled complaint report for Newton Co. and summitted to Law Enforcement Officer.
- Recall work on BMP truck.
- Sent BMP information to consultant for newsletter.
- Attended Forest Action Plan meeting.
- Attended Forestry Day at Capital and gave booklets out.
- Submitted 319(h) grant to Arkansas Natural Resource Commission (ANRC).
- Received BMP review information from Georgia Forestry Commission.
- Contacted Arkansas Department of Environmental Quality (ADEQ) about complaint report in Izard County.
- Contacted by AFC Ranger in Izard County on a complaint that was sent in.

Forest Inventory and Analysis (FIA): AFC in cooperation with USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 70 plots for the month of January. We are now 94% complete with INV2018. We should finish this month.
