Dear Co-Chairs:

Attached are my recommendations for reappropriation of various infrastructure projects for the 2027 Fiscal Year. The recommendations reflect the anticipated need for reappropriation as requested by the agencies and will ensure sufficient appropriation is available to continue existing projects. The recommendations are separated by fund accounts for your review.

Included in my recommendations, I have recommended to continue appropriation for new campus for the Arkansas School for the Blind and Deaf. This project sends a message: Arkansas supports every student, of every background, at every school in the state. It is an enormous investment for this campus, for every blind and deaf Arkansan, and for our entire state.

In addition, I have recommended to continue appropriation for the State Crime Lab construction project. Arkansas' new crime lab will offer the state-of-the-art support our law enforcement officers need to build a safer, stronger Arkansas.

On behalf of the Higher Education Coordinating Board, I am also including reappropriation of various infrastructure projects for the institutions of higher education for the 2027 Fiscal Year. These requests do not require my recommendation.

I respectfully request that the projects on the attached schedule be introduced as Joint Budget Committee Bills.

In addition, I respectfully request the following amendment to the 2026-2027 bill for the Department of Corrections - Division of Correction Reappropriation once introduced.

Immediately following Section 4, please insert the following and renumber accordingly:

SECTION XX. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND USAGE RESTRICTIONS. The Department of Corrections shall use funds reappropriated in Section 1(A) for the purpose of creating capacity, including expansion of recidivism reduction programs, infrastructure improvements, capital improvements, and the addition of bed space to relieve county jails of state inmates. The Department shall not spend any funds reappropriated in Section 1(A) for the purpose of constructing a prison in Franklin County, Arkansas.

The provisions of this section shall be in effect only from July 1, 2026 through June 30, 2027.
