

Dear Co-Chairs Johnson and Cavenaugh:

The Department of Finance and Administration is requesting a suspension of the rules for the purpose of placing on the ALC Review Subcommittee agenda for next Monday the review of a contract with Idemia (contract 4600040471). The item for review is the addition of \$1,500,000 to the contract value. This contract is for the physical card stock and supplies associated with the production of State issued driver's licenses and identification cards.

The need to increase the value of the contract arises out of a significant and unexpected increase in the issuance of driver's licenses and state ID's over the past 90 days caused by the need for duplicate licenses and identification cards due to the March tornadoes and flooding in the state, and, more significantly, the U.S. Department of Homeland Security's recent commencement of enforcement of the Real ID standards for travel. As a point of reference, since April 1, 2025, DFA has issued over 150,000 Real ID's, an amount that is 15 times our typical monthly issuances. There is a significant demand nationally for the ID card stock due to Real ID, and approval of the increase in contract value will enable DFA to avoid shortages in its card inventory.
