Dear Senator Johnson and Representative Cavenaugh:

The Arkansas Department of Finance and Administration respectfully requests a suspension of the rules of the Arkansas Legislative Council – Review Subcommittee to allow for the review of an information technology contract associated with the development of a new mobile application that will provide Arkansans with access to services across all of state government.

The Department has been engaged in the procurement process for these services for several months. Due to the complexity of the contract negotiations and the requisite legal review, the process required additional time beyond what was initially anticipated. Consequently, while the Department finalized the contract on January 5, 2026, completion occurred only hours after the deadline for submission to the Subcommittee.

Accordingly, the Department respectfully submits this request for a suspension of the rules to permit consideration and review of the contract at the Subcommittee's January 13th meeting. Approval of this request will allow work on the project to commence this month and be completed in the Fall of 2026.
