Due to the AGENCY REQUEST need-to-meet-the-minimum compensation schedule-as-established-by-Act-74 of-the-2nd-Extraordinary-Session-of-the-84th-General-Assembly,-or-its successor, for-public-school-teachers, counselors, and librarians-and-other education professionals as listed in subsection (a) below, the Arkansas School for the Deaf is authorized to adjust current or new employees to at least the minimum level of compensation for public school employees. For current or new employees in the positions listed in subsection (a) below, the Arkansas School for the Deaf may implement salary adjustments to maintain equity between their teacher salaries and those of Central Arkansas Public School Systems only after a plan for determining and implementing those adjustments has been reviewed by the Office of Personnel Management and by the Personnel Committee of the Arkansas Legislative Council or Joint Budget Committee and approved by the Chief Fiscal Officer of the State.
