The Arkansas State Board of Election Commissioners is requesting a transfer of appropriation from the Cash Fund Holding Appropriation as authorized in Act 152 of 2024, Section 27 (1) as follows:

Funding for this appropriation will be received by an accompanying Restricted Reserve request. These funds will be used to procure an outside attorney to represent the agency and the state in the Western District Federal Court Case, *Get Loud Arkansas et. al, v. Thurston et. al.*, Case No. 5:24-CV-05121.

The Case is filed against the State Board of Election Commissioners (SBEC) for their proposal and adoption of the *Rule Regarding Voter Registration*. The Rule was approved as an emergency rule and is now in the process of becoming permanent. The Arkansas Attorney General's Office was unable to represent the SBEC because of a potential conflict that would potentially interfere with their ability to represent the agency and the State.

The SBEC does not have appropriation or funding, as part of its normal biennial budgeting, for the retention and employment of outside counsel. The request for appropriation and funding is to permit the SBEC to engage and retain outside counsel to represent the SBEC and the State in this federal litigation.

Overview + Job Creation Commitment //

- TXK Regional Airport has over 200 acres available for development.
- Dean Baldwin Painting, based in San Antonio, plans to relocate to the airfield.
- The company provides aircraft paint processes and has been in business for nearly 60 years.
- They propose building over 175,000 sq. ft. of hangars on airport property.
- The project would create 150 jobs with an average salary of \$50,000+ annually.
- Dean Baldwin Painting currently paints Boeing 777/787 aircraft for American and United Airlines.
- The company seeks additional land to expand and create 150 more jobs.
- The Texarkana Airport team met CEO Barbara Baldwin-McNulty on April 10, 2024, in Chicago.
- The Airport Authority plans to use at least 3 State grants from the Arkansas Department of Aeronautics for storm water and environmental mitigation, totaling approximately \$750,000.
- The Airport Authority will seek EDA grants for an entry road and site utilities.
- Dean Baldwin Painting requests an IRB Bond with a 30-year leaseback and two 10-year options.
- An MOU will be entered into pending discussions with AEDC to start an Environmental Assessment and determine building costs.

Federal Commitment //

- Federal partners, including Congressmen Bruce Westerman, Pat Fallon, and Nathaniel Moran, secured \$29.1 million for the project.
- Funds will be used for runway extension, taxiway widening, and apron improvements.
- The funding was approved on March 6, 2024, as part of the Appropriations Bill.

State of Arkansas Support //

- FAA feedback indicates that state funding for runway overlay would expedite project approval.
- On June 28, 2023, Arkansas Secretary of Commerce Hugh McDonald and his team discussed the project at Texarkana Regional Airport.
- The State's assistance is needed for runway overlay, taxiway extension, and taxiway widening.
- Local officials, including Representatives Carol Dalby and Lane Jean, and mayors Allen Brown and Bob Bruggeman, have committed over \$3.2 million in local matching funds.
