

Dear Mr. Hudson:

The Arkansas Department of Parks, Heritage, and Tourism, Division of Arkansas State Parks request a Various Temporary Appropriation increase of \$2,500,000 for the division's Conservation Tax FY2025 appropriation – SPT0100. This appropriation is used to support the Parks Operations. The additional appropriation is needed to allow for payment of increased operational costs across the division. Increases in expenses have already been recognized in our utilities, supplies (maintenance/housekeeping), amenities (sheets/coffee/soaps), and facilities maintenance categories. The increase in expenses is being seen sooner at the conclusion of a busy summer season.

The department is requesting a total increase for FY2024 of \$2,500,000 in Fund SPT0100, Fund Center 500, Commitment Item 502:00:02 and Business Area 0900.

Fortunately, due to increased revenue from conservation sales tax, ADPHT has sufficient fund balance to increase this commitment line item. Respectfully, we are asking that the additional appropriation request be placed on the next PEER Committee agenda.
