
## Arkansas Plan for Expanding the Public Health Workforce within the Aging Network for States

Arkansas will be using these funds through the Area Agencies on Aging (AAA's) to recruit, hire, and train public health workers to respond to the COVID-19 pandemic and prepare for future public health challenges. These funds will be used to offset costs of hiring a range of public health professionals, including but not limited to social support professionals, community health workers, communication and policy experts and "other positions as may be required to prevent, prepare for, and respond to COVID-19....

Professionals funded through this program will provide a wide range of public health services and supports, including culturally affirmative and linguistically accessible information, assistance with accessing vaccines (including boosters) and connecting to other services, transition and diversion from high-risk congregate settings to community living, health and wellness programs, activities that address social isolation and social determinants of health, and other activities that support the public health and wellbeing of older adults and people with disabilities.

Our plan will be to distribute the funds to the Area Agencies on Aging utilizing the Arkansas Older Americans Act Intrastate funding formula (IFF) with no administrative cost deducted. Allocated amounts are as follows:

### **Budget Plan – Aviation Academy**

UCA Aviation Academy and its partners request funds from the state in the amount of \$750,000 that will be matched 2:1 by \$1,500,000 from the UCA Foundation to complete the UCA Aviation Academy Hangar. The facility will be at the Conway Regional Airport on the Corporate Hangar Row and will be 100\*80 feet for the academy planes and 2,000 square feet for instruction. The UCA Foundation funds will be directed to construction while the state funds will be for finish out and equipment. The hangar will have a simulation area, classroom, testing center, offices, & conference space. Land is procured, and the hangar will be on the corporate ramp with easy access to the runway. The hangar will allow us to increase the number of planes used for flight training, therefore increasing the number of students accommodated by our program by twice the current 40 students. We will be able to maximize instruction and make our processes more efficient and effective by increasing annual graduates by 200%. Aerospace and defense are critically important elements of the Arkansas economy, and the state faces critical skilled worker shortages in aviation. Demand for pilots is at an all-time high and runs the gamut from cargo haulers to airlines to private and general aviation. The demand for pilots is only increasing in business and military, so UCA's academy is much needed. Arkansas citizens are responding by enrolling in UCA-AA at three times the numbers forecast when the program was announced in October 2023.

The State of Arkansas, Department of Finance and Administration, Office of Intergovernmental Services (DFA-IGS) is requesting the availability of grant funds of \$17,000,000 for the Victims of Crime Act (VOCA) program from the ARPA – State-Indirect appropriation within the DFA – Disbursing Officer.

The Victims of Crime Act (VOCA) of 1984 was passed by Congress to assist states in providing high quality services that are directly related to the emotional healing and recovery of crime victims. VOCA funds support a broad array of programs and services that focus on helping victims in the immediate aftermath of a crime and supporting them as they rebuild their lives.

The primary revenue source for VOCA grants is the Crime Victims Fund, which is funded through fines, penalties, and forfeitures collected from persons and companies convicted of offenses against the United States. The U.S. Department of Justice, Office of Victims of Crime (OVC) administers these funds at the federal level while DFA-IGS administers VOCA funds at the state level. Applicants are encouraged to submit projects aligned with the Goals & Objectives adopted by the Advisory Board as the State of Arkansas Victim Services Plan.

Allowable direct services/activities include:

- Immediate emotional, psychological, and physical health and safety of a victim.
- Personal advocacy and emotional support
- Mental health counseling and care
- Peer support
- Facilitation of participation in criminal justice and other public proceeding arising from the crime
- Legal Assistance
- Forensic Medical Evidence Collection Examinations
- Forensic Interviews
- Transportation
- Public Awareness
- Transitional Housing Services; and
- Relocation services

Awards will be made for a twelve (12) month period from October 1, 2023, through September 30, 2024. Awards may be eligible for a one (1) year continuation that is dependent upon available funds and the previous year's performance. Awards will be limited to a maximum of \$300,000. A total of 118 applicants have been received.

Springdale Regional Fire Training has a priority list of projects that include the following:

Classroom structure addition at Fire Station 4 site \*approximately \$400,000

The Mickey Jackson Training Center is the main training campus for the department. However, it is remote for stations in the western corridor of the city (Stations 6, 7, and 9), leading to extended travel times and creating gaps in service and response times. The distances and drive times from the stations to the existing training center are as follows:

- Station 9: 8.8 Miles (20-23 minute drive time)
- Station 7: 7.9 Miles (18-21 minute drive time)
- Station 6: 5.8 Miles (15 minute drive time)

\*Distance and times retrieved from Google Maps

To address this issue, adding a satellite Training Facility at Station 4 would benefit the west-side stations and the areas they serve. This satellite location would also house technical rescue props, including a rappel tower, confined space rescue prop, and trench rescue prop, allowing specialty rescue apparatus and resources to be centrally located within the city during training. The classroom is centrally located in the City of Springdale as well as the Northwest Arkansas region. The Fire Station 4 site has close access to I-49 and will be used for training delivery and regional meetings (*for example: currently the NWA Fire Chiefs – Operations Chief Group meets at Springdale Fire Station 6*). The classroom facility there is small and does not include adequate technology to deliver remote access. The new room will have the ability to broadcast to remote locations including outlying fire stations and other fire departments.

### Engineered Trench Rescue Prop \*approximately \$100,000

Technical rescue work is low-frequency, high-risk work. Engineered props provide an environment for learning and practicing skills in a controlled environment. No engineered trench prop is available in Northwest Arkansas (anywhere in Arkansas that we are aware of). This will be utilized by technical rescue responders and students throughout the region.

# Site work/hard surface \*total approximately \$250,000 (we will only use the amount necessary to adequately access the projects we can fund immediately).

A combination of heavy duty concrete and asphalt for all-weather, durable driving and parking surface at the training site.

### Flashover simulator \*approximately \$100,000

This facility will be used for training of regional firefighter recruits as an approved satellite campus of Arkansas Fire Training Academy for Firefighter Standards classes available to all departments in Northwest Arkansas. We also host regional Arkansas Fire Academy, National Fire Academy, and vendor outsourced specialty courses offered regionally through the Northwest Arkansas Training Officers Association. This particular prop provides a controlled environment to introduce new firefighters to the heat expected while performing structural firefighting. It also allows more advanced training to firefighters and fire officers by

demonstrating the effects of ventilation on fire growth, rapid fire propagation events and the situational awareness or tactics necessary to avoid them.

The drill tower with technical rope and confined space engineered training props are not included in this package as the available funding won't support all. We will continue to actively pursue these elements over time.
