# Arkansas Attorney General Quarterly Report Pursuant to Ark. Code Ann. § 25-16-718(c) Period 07/01/2025 to 09/30/2025

#### CASE NAME AND BRIEF DESCRIPTION OF COURT ORDERS OR SETTLEMENT AGREEMENTS

#### Real Travel, LLC

State of Arkansas v. Real Travel, LLC; Bart Bowe; and Brian Scroggs - Real Travel entered into a Consent Judgment with the Attorney General for violations under the Arkansas Deceptive Trade Practices Act. Defendant is permanently restrained and enjoined from conducting any and all business related to timeshare and timeshare exit industries in the State of Arkansas.

#### Carolina Tobacco Company

Carolina Tobacco was a tobacco manufacturer that went bankrupt around 2005. When it went bankrupt, it had outstanding obligations including civil penalties owed to Arkansas, as well as obligations to numerous other states. Payments received by Arkansas are for civil penalties owed.

#### • Dodge Off Road, LLC

The State filed a complaint against Defendants violated the Arkansas Deceptive Trade Practices Act, Ark. Code Ann. § 4-88-101 et seq., when they failed to deliver items for which consumers prepaid or failed to deliver those items in a reasonable amount of time. Defendants also failed to refund monies paid by consumers in Arkansas, across the country, and internationally for unfulfilled orders or substandard products. The State filed an Amended Complaint on February 14, 2025, that included 108 consumers; several consumers filed a consumer complaint with the Office of the Attorney General ("OAG") after filing the Amended Complaint.

## National Opioid Settlement Fund

The Arkansas Attorney General filed a lawsuit against McKesson, AmerisourceBergen, and Cardinal, the three largest distributors of opioids, for their role in the national opioid epidemic. Arkansas is set to receive over \$177M over 17 years as part of the national settlement reached with the companies and state attorneys general.

#### • Grand River Enterprises

State of Arkansas v. Grand River Enterprises - The Attorney General worked with Grand River to obtain a Settlement Agreement and assurance of voluntary compliance for its failure to comply with Arkansas's tobacco statutes.

#### Community Builders Inc.

In 2025, the State filed its complaint against Greg Wolter, Nathan Wolter, and their business, Community Builders, Inc., alleging violations of the ADTPA in that defendants misrepresented their ability to complete the bathroom and shower remodels that included the installation of handicap-accessible showers, by fraud or false pretense solicited contracts that they knew they would not be able to perform on, concealed their use of consumer funds for purposes other than consumer's projects, and retained consumer downpayments even after it was apparent they could not perform on the contracts.

#### Hub Inc.

The Office of the Arkansas Attorney General maintains the Approved-for-Sale Tobacco Products Directory ("Directory") for the State of Arkansas. Pursuant to Ark. Code Ann. § 26-57-1303(c)(1)(B), it is unlawful for any person to sell, offer, or possess for sale in the State of Arkansas cigarettes of a tobacco product manufacturer or brand family that the person or entity knows is not included in the Approved-for-Sale Tobacco Products Directory maintained by the Attorney General. Records reflect that Hub Inc. sold 60 packs of the cigarette brand Exeter. Exeter has never been listed on the Arkansas Directory. No sales of Exeter should have occurred in the State of Arkansas.

#### • Jay & Dora Edmonson dba The Resort Place Travel

The Attorney General filed a lawsuit on February 2, 2017 against the defendants for advertising travel and vacation vouchers, receiving money from consumers for the purchase of travel and vacation vouchers, and failing to secure lodgings for consumers' vacations, causing consumers to pay out-of-pocket for lodgings at their destination. The parties entered into a Payment Plan Agreement where Defendants agreed to pay \$400.00 per month until the judgment has been satisfied.

## Jean Butler

Jean Butler facilitated a multi-million dollar international sweepstakes scheme. Ms. Butler received funds from victims of the scam and funneled money to operators of the scheme in Jamaica.

## LLT Management / Johnson & Johnson (Talc)

This enforcement action was brought by the Attorney General upon the ground that Johnson & Johnson engaged in unfair or deceptive acts and practices in or affecting commerce in violation of Ark. Code Ann. § 4-88-107(a). This settlement arose from allegations that Johnson & Johnson deceptively promoted and misled consumers about the safety and purity of its talc-based powder products that had been sold by the company for over a hundred years.

# Joseph Schwartz

On April 30, 2025, Joseph Schwartz of New York pleaded guilty to one count of Medicaid Fraud, a Class B Felony and one count of Attempt to Evade or Defeat Tax, a Class C Felony. He was sentenced to twelve months in the Arkansas Department of Corrections with an additional forty-eight months suspended imposition of sentence; ordered to pay a \$2000 fine, court costs, and restitution totaling \$1,801,620.53. This defendant was the principal owner and president of Skyline Healthcare, LLC. He owned and managed multiple nursing homes in the State of Arkansas that received payments for Medicaid recipients in their care. Schwartz made omissions and materially false statements to the Arkansas Medicaid Program that affected the determination of the per diem rates that were paid to those facilities. Tax withholdings were taken from the salaries of employees of these facilities and Schwartz failed to file withholding documents and failed to remit the withholding to the Arkansas Department of Finance & Administration.

#### National Opioids Trust - ALLERGAN

The Arkansas Attorney General filed a lawsuit against Allergen for the company's role in the national opioid epidemic. Arkansas is set to receive over \$19M over 7 years from Allergen as part of the national settlement reached with the company and state attorneys general.

# National Opioids Trust - CVS

The Arkansas Attorney General filed a lawsuit against CVS for the company's role in the national opioid epidemic, including inadequately monitoring opioid prescriptions. Arkansas is set to receive over \$44M over 10 years as part of the national settlement reached with CVS and state attorneys general.

#### National Opioids Trust - TEVA

The Arkansas Attorney General filed a lawsuit against Teva for the company's role in the national opioid epidemic. Arkansas is set to receive over \$36M over 13 years from Teva as part of the national settlement reached with the company and state attorneys general.

#### Phatiffany Cook dba Hourglass Vixens

Defendants purport to provide cosmetology treatments; body-modification therapy; and dental, medical, and massage services, many of which require licensing in Arkansas. Defendants purport to be licensed in certain areas of massage therapy, cosmetology, and dentistry. Defendants are not licensed in these areas. This is a violation of Arkansas law. In addition, Defendants have failed to perform services for which consumers' money was accepted in violation of ADTPA.

#### Pamela Townsend-Bell

This case involved Defendant, Pamela Townsend-Bell, an LCSW, billing for services provided by two Social Work Interns who were not properly credentialed. The case resulted in the defendant entering a guilty-plea for two class 'C' felonies, being sentenced to 60 months' probation, and ordered to pay restitution of \$11,765.62, a fine of \$23,531.24, and court costs.

#### Rising Eagle

A Texas-based robocalling operation made millions of calls to Arkansas residents in violation of the Telephone Consumer Protection Act, the Telephone Sales Rule, and the Arkansas Deceptive Trade Practices Act. The Arkansas Attorney General participated in multistate litigation against the callers for these unlawful practices.

#### Robert Stevens dba Pro-Pave Asphalt

Pro-Pave claims to be an asphalt surfacing company. According to consumer complaints, the company travels door-to-door offering to lay asphalt surfaces with leftover products from other jobs. Once the job is completed, the company quotes the consumer a much higher price than agreed upon initially. If the consumer does not produce payment, the company employees engage in aggressive tactics to obtain the payment.

# Robert Walley dba The Iron Shop

The Iron Shop of Arkansas claimed to be a small contracting business that installed and conducted maintenance on gates and fencing. During approximately five months, consumers filed complaints alleging that the business performed poor work or did not complete projects. When the consumers contacted the business for repair or refunds, their calls were ignored, or they were given dates and times in which no one showed to make the repairs or complete the work.

#### **Clearing Account**

Inflows of cash through court ordered judgments against companies or assurances of voluntary compliance are initially deposited into \$ 4,245,084.68 this account.

#### **Consumer Education and Enforcement Account**

Account is funded through court ordered judgments against companies or assurances of voluntary compliance. Outflows of cash are \$ 244,846.44 made in accordance with Ark. Code Ann. § 4-88-105(e)(3).

# **Restricted Account**

Account is funded through court ordered judgments or settlements, where the use of funds is restricted by the judgment or settlement. \$ 181,369.83 Outflows of cash are made in compliance with the terms of the judgment or settlement.

#### **Opioid Settlement Account-Restricted**

Funds from the opioid settlement agreements are deposited into this account. Outflows of cash are made in compliance with the terms \$ 10,589,751.17 of the opioid settlements.

# **Opioid Restricted Discretionary Account**

Restricted discretionary funds from the opioid settlement agreements are deposited into this account. \$ 984,296.69

# **MFC Settlement Account**

Account is funded through restitution payments to recover expenses incurred during investigation and prosecution of Medicaid Fraud \$ 174,092.07 (Act 916 of 2019).

All cash fund balances above do not take into account any outstanding checks. Actual balance may be less.
