I am writing to request additional appropriation pursuant to Act 168 of 2026, Section 31 for the Rural Health Transformation Program to ensure proper alignment of funding with current operational needs.

Specifically, I request that \$4.5 million be added to the Maintenance and Operations Commitment Item (02). This increase is necessary to accommodate contract expenses associated with the BDO Government Services grant management contract, which are operational in nature and appropriately classified within Maintenance and Operations. This request is submitted as a Various Temporary Appropriation (VTA). An equivalent reduction will be made to the Grants and Aid Commitment Item (04), resulting in no net change to total program appropriation. The purpose of this adjustment is solely to position existing appropriation correctly to support required expenditures.
