Dear Secretary Hudson:

The Department of the Military is requesting \$243,000 from the Restricted Reserve Fund under Act 1017 of 2025, Section 3(a), to support the state share of a critical infrastructure initiative. The funds will be used for the design of an addition to the 39th Infantry Brigade Headquarters on Camp Robinson.

If approved, this state investment will leverage approximately \$729,000 in federal funding from the National Guard Bureau, resulting in \$972,000 in total funding. This combined investment will significantly enhance the readiness and operational capabilities of the Arkansas National Guard.
