The Arkansas Department of Corrections – Division of Correction (ADC) is requesting \$10,000,000 in supplemental FY22 appropriation for funding awarded by the Arkansas CARES Act Steering Committee under Section 35 of Act 997 of 2021, Regular Session, to replace appropriation for previous COVID-19 related expenses used throughout the remainder of the fiscal year. To date, the ADC has spent more than \$4 million on COVID related items, including masks, tests, and various other supplies for quarantined offenders without requesting additional appropriation. This additional appropriation will allow us to replenish what we have spent throughout the year.

In Fiscal Year 2022, the Administrative Office of the Courts (AOC) applied for and received \$575,000.00 Coronavirus Emergency Supplemental Fund (CESF). The AOC submitted two invoices for reimbursement to the Arkansas Department of Finance and Administration (DFA). The first invoice was reimbursed and the appropriation was restored for those funds. The second invoice has now been reimbursed and the AOC currently seeks to restore the appropriation for those funds.

This is a one-time appropriation increase to restore appropriation used to spend CESF awards. Accordingly, the AOC is requesting the necessary appropriation restoration of \$200,274.52.

The Arkansas School for the Deaf (ASD) is requesting Various Temporary Appropriation authorized under Section 33 of Act 997 of 2021, in the amount of \$407,000.

The school has a large amount of salary savings due to being unable to fill lower grade jobs. Presently speaking there are eighteen vacant positions at the school. The Residential Advisor and Educational Paraprofessional, two of the most crucial jobs at the school, experience a lot of turnover. The school did implement the new higher pay grade scale in November for grades GS01 – GS05 and hopes to experience less turnover moving forward. The school would like to utilize the salary savings on campus by adding appropriation to their maintenance and operations category, along with a small amount added to their travel and contract categories.
