The Department of Transformation and Shared Services Division of Information Systems (DIS), respectfully requests a transfer of \$5,000,000 in appropriation between commitment items 44 and 46 in accordance with Section 6 of Act 30 of 2024.

During this fiscal year DIS has worked to replace firewalls for the entire K-12 Broadband network and has projects at multiple state parks to improve their connectivity, greatly reducing available appropriation. This request will move existing appropriation to a commitment item that can be used for delivery of services to the Division's customers.

Dear Secretary Hudson:

I am writing to request an appropriations transfer as authorized in Section 8 Special Language in Act 163 of 2024. Specifically, I am requesting that \$20,000 (twenty thousand dollars) be moved within Section 3 from Regular Salaries and added to the line item for Professional Fees for FY2025.

The Auditor of State's office is in the process of coding software programs to work congruently with banking data to continue automating reconciliation of the 2,500-plus unclaimed property checks issued each month. The Auditor's office is also currently preparing to move to a new secure data center to host our accounting and check printing software. The current hardware is no longer being serviced by the manufacturer. We are fortunate to have as a consultant the original software programmer who knows our software extensively and has been instrumental in our transition to AASIS and automation. This move will help my office cover much needed additional professional fees and service costs for the remainder of this fiscal year. Due to the unforeseen need to outsource those services our Professional Fees line item is running low.

Thank you for your consideration and I would be happy to answer any questions you or the General Assembly might have about this request.
