Dear Co Chairs:

The Department of Labor and Licensing requests prior approval of the Arkansas Legislative Council for the transfer of positions and appropriation necessary to support shared services operations within the cabinet-level department.

This request is for approval of the transfer of four positions and appropriation that will result in no overall increase in positions or appropriation for the Department. The GS7 Position will serve two boards and the transfer will enable the splitting of the position between the two boards financially. The extra help positions are being transferred to enable the department to provide help to various boards during renewal times or provide a hearing officer when needed. Once in shared services the costs of these positions can be charged to the board receiving the service for the hours utilized. The transfer of the Fiscal Support Analyst position will be used in the accounting section. The accounting staff is extremely shorthanded with four individuals doing the work for 18 boards in addition to the Labor division work.

The appropriation transfers for CI 02 will enable the rent, internet, copier, etc. to be paid with one warrant as opposed to 18 different warrants. The multiple warrants have been creating issues when vendors misapply payments.

The attached request requires the approval of appropriation transfers by the PEER Subcommittee and position transfers by the Personnel Subcommittee of the Arkansas Legislative Council.
