AMENDMENT SUMMARY: The proposed amendment allows microbreweries to self-distribute by obtaining a microbrewery-restaurant wholesale license. This proposed Amendment is in response to Act 207 of the 2023 Regular Session of the Arkansas General Assembly.

(48) Microbrewery-Restaurant Wholesale Permit authorizes the sale and transport beer, malt beverage, or hard cider manufactured by the microbrewery-restaurant licensee to licensed retailers in an amount not to exceed five thousand (5,000) barrels per year. To sell and transport under ACA § 3-5-1204(a)(10)(A), the microbrewery-restaurant licensee shall obtain a microbrewery-restaurant wholesale permit.
