AMENDMENT SUMMARY: The proposed amendment allows liquor stores to sell clothing products that contain advertising material. This proposed Amendment is in response to Act 684 of the 2023 Regular Session of the Arkansas General Assembly.

**1.33 (2) Premises Operated in Conjunction with Certain Other Businesses.** No off premises retail liquor permit shall be operated as part of the profit making business of any billiard hall, pool room, drug, grocery, sporting goods, dry goods, hardware, general mercantile store, or any other business unrelated to such permit; however, the retail liquor store permittee may have tobacco products, mixers, soft drinks, consumables and edible products that complement alcoholic beverages, <u>clothing and other</u> <u>promotional or marketing merchandise with logos or graphics of the permittee's business</u>, and other items customarily associated with the retail package sale of the liquors.
