AMENDMENT SUMMARY: The proposed amendment permits for certain distillers, manufacturers, or small farm wineries in dry areas to exclusively sell to wholesalers. This proposed Amendment is in response to Act 747 of the 2023 Regular Session of the Arkansas General Assembly.

- **2.76** The board may issue a license to a small farm winery in a dry area if the small farm winery sells exclusively to wholesalers as authorized under § 3-8-203.
- **2.86** The division may issue a permit to a distiller or manufacturer in a dry area if the distiller or manufacturer sells exclusively to wholesalers as authorized under § 3-8-203.
