AMENDMENT SUMMARY: The proposed amendment allows bars to expand outdoor operations without getting prior approval. This proposed Amendment is in response to Act 882 of the 2023 Regular Session of the Arkansas General Assembly.

1.16 "Premises" means any place, building, or structure, which is shown on a floor plan or site plan submitted to and approved by the Alcoholic Beverage Control Division for the sale or consumption of alcoholic beverages. Should there be expansion of the permitted premises, notice must be given to ABC.

29	restaurant or bar with approval from the local government zoning authority of
30	the municipality or county in which it is located without obtaining prior
31	approval from the division.
32	(2) A restaurant or bar seeking approval to expand outdoor
33	dining under subdivision (a)(1) of this section shall provide notice to the
34	division of the expansion and change in floor plan.
35	(b) If the expansion in outdoor dining increases the seating capacity
36	in a way that could result in a change in permit type, the restaurant or bar

1	shall obtain division approval prior to expanding the outdoor dining area at
2	the restaurant or bar.
3	(c) A restaurant or bar that expands outdoor dining under this section
4	shall comply with division rules regarding outdoor dining.
5	(d) As used in this section:
6	(1) "Bar" means an establishment that is:
7	(A) Licensed by the division to sell alcoholic beverages

9	(B) Not a restaurant; and

20	(E) Serves at least one (1) meal per day; and
21	(F) Is open a minimum of five (5) days per week, with the
