Dear Senator Davis and Representative Berry:

The Office of Personnel Management (OPM) requests the suspension of the Committee Rules for Supplemental Agenda Item requiring submission in advance of a committee meeting to approve eligible state employees to receive their merit increase added to their base salary and the resulting salary to exceed the maximum pay level of their grade pursuant to Arkansas Code § 21-5-1101(d).

On Friday, June 14, 2024, Governor Sanders issued her decision regarding state employee merit increases for Fiscal Year 2024. The Governor's announcement was made after the Committee's deadline for submission; therefore, OPM is now submitting for your approval the list of employees whose current salaries will exceed the maximum pay level for their assigned grade resulting from the merit increase.

OPM has determined the effective date for eligible state employees to receive their merit increase is July 7, 2024. This request for approval requires immediate action and is necessary to ensure timely and consistent implementation of merit increases for all eligible state employees.

Your favorable approval of this request would be greatly appreciated.
