Dear Senator Davis and Representative Berry:

The Arkansas Department of Public Safety (DPS), Division of State Crime Lab, has requested a special entry rate of \$375,000, that exceeds the maximum, for an exceptionally well qualified applicant for the classification of Crime Lab Associate Medical Examiner, L004N, grade MP09.

Emily Ogden's background includes a Doctor of Medicine, multiple certifications, and over fifteen (15) years of experience in the fields of medicine and pathology. The following is a detailed comparison of the minimum qualifications of the classification and Dr. Ogden's experience.

## MINIMUM REQUIREMENTS:

The formal education equivalent of a medical degree approved by the Council on Medical Education of the American Medical Association and successful completion of the internship or resident postgraduate requirements; plus six years of progressively more responsible experience in a chemical or forensic laboratory; plus three years in a professional managerial or supervisory capacity.

Must be licensed as a Physician by the State Medical Board in accordance with ACA §17-95-401 and §17-95-403. Must be board certified, or eligible for board certification, as recognized by the American Board of Pathology, in Forensic Pathology.

#### JUSTIFICATION:

Statewide, there are six (6) positions classified as Crime Lab Associate Medical Examiner with an average annual salary of \$293,007.14 and 16.1 years of state service. Of these positions, all are located within the State Crime Lab. The statewide turnover rate for this classification was 0% within the previous year.

Act 138, Section 54, of Fiscal Session 2024 states the following:

SECTION 54. SPECIAL LANGUAGE, NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW, CIME LAB MEDICAL EXAMINER SALARIES. In order to recruit and retain employees that meet the licensure requirements for Medical Examiners published in Arkansas Code Annotated § 12-12-307 (a)(2), the Department of Public Safety- Division of Arkansas State Crime Laboratory, may exceed the maximum salary level by no more than fifty percent (50%) for the following authorized classifications:

- (1) L001N Crime Lab Director Medical Examination Division Grade MP10
- (2) L004N Crime Lab Associate Medical Examiner Grade MP09

Increases in accordance with this special language shall only be implemented after receiving approval from the Arkansas Legislative Council or Joint Budget Committee.

Dr. Ogden exceeds the minimum gualifications for the classification and is currently employed as a Medical Examiner at Texas A&M University with her annual salary in March 2025 when she will begin working for the Arkansas State Crime Lab will be \$303,390. The State Crime Lab states that Dr. Ogden's extensive experience, national recognitions, and role as a published academic would make her a valuable addition to the State Crime Lab. Her familiarity with forensic pathology programs would shorten her orientation time and allow her to begin working quickly as a Medical Examiner and not in an administrative capacity, although she will be heavily tied to administrative roles as well as performing autopsies. Her role will be that of the Deputy Medical Examiner for the agency. DPS states that this hire will cost approximately \$474,300, including fringe, and that all funds will be paid out of general revenue received during the fiscal session.

The Office of Personnel Management has reviewed this request and recommends approval of the requested rate of \$375,000, for the classification Crime Lab Associate Medical Examiner, MP09. This is an increase of \$109,374, or 41.2%, over the maximum of the grade. This will be an increase of \$71,610, or 23.6%, from her annual salary at the time of hire.

The Arkansas Department of Public Safety (DPS), division of Arkansas State Crime Lab (ASCL) would like to request a salary of \$375,000 for Dr. Emily Ogden in an L004N Crime Lab Associate Medical Examiner position. This is in accordance with Section 54 of Act 138 of the Fiscal Session 2024:

SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CRIME LAB. MEDICAL EXAMINER SALARIES. In order to recruit and retain employees that meet the licensure requirements for Medical Examiners established in A.C.A. §12-12-307(a)(2), the Department of Public Safety - Division of Arkansas State Crime Laboratory, may exceed the maximum salary level by no more than fifty percent (50%) for the following authorized classifications:

(2) L004N Crime Lab Associate Medical Examiner Grade MP09

Increases in accordance with this special language shall only be implemented after receiving approval from the Arkansas Legislative Council or Joint Budget Committee.

Dr. Ogden has an M.D. from Texas A&M University and her board certification in Anatomic and Clinical Pathology and in Forensic Pathology. She has served as a medical examiner and assistant professor for 10 years and been the director of the Forensic Pathology Fellowship Program for the university of Texas five and one-half years. Dr. Ogden also served as the chief resident at the Medical University of South Carolina during her residency. Dr. Ogden's education, training, and skills will fill a vital need at the Crime Lab. She will serve as the Deputy Medical Examiner.

Crime Lab has the funding for this request. This salary will not create any inequities with the other associate medical examiners.
