WHAT IS PSLF?

- Public Service Loan Forgiveness
- Established by George W. Bush in 2007
- Applies only to those working full-time for qualifying employers
- Must make at least 120 monthly payments (10 years of payments)
- Represents only 1% of all outstanding student loan debt

WHY THE STATE OF ARKANSAS IS INTERESTED IN PSLF

- PSLF represents a long-term retention strategy—employees have made 10+ years of payments and government or non-profit service to qualify
- Provides a rare recruiting advantage unique to public sector

WHY ASSISTANCE IS NECESSARY

- 98% of all applications are denied, mostly for failure to navigate a maze of federal bureaucratic red tape
