Dear Senator Davis and Representative Warren:

The Office of Personnel Management (OPM) submits a Reduction in Force (RIF) report from the Arkansas Department of Health (ADH) and the Arkansas Department of Parks, Heritage and Tourism (ADPHT) for your review. Both ADH and ADPHT implemented a RIF due to the sudden loss of federal funding. Fifteen (15) employees were affected by the ADH RIF, and the effective date of separation was March 28, 2025. Nine (9) employees from the ADH RIF have since found employment within ADH or other departments. Two (2) employees were affected by the ADPHT RIF, and the effective date of separation was April 11, 2025.

ADH and ADPHT requested severance pay for eligible employees based on their years of service. The approximate cost of the severance payments for the ADH employees was \$15,500. The approximate cost of the severance payments for the ADPHT employees was \$2,400. The affected employees have been placed on the OPM Reduction in Workforce List and will receive special re-employment consideration for up to one-year from the date of separation. The list of employees is attached.
