22	SECTION 1. Arkansas Code Title 17, Chapter 83, is amended to add an	ı
23	additional subchapter to read as follows:	
24	Subchapter 4 — Dietitian Licensure Compact	
25		
26	17-83-401. Text of compact.	
27	The Dietitian Licensure Compact is enacted into law and entered into	by
28	this state with all states legally joining therein and in the form	
29	substantially as follows:	
30		
31	<u>DIETITIAN LICENSURE COMPACT</u>	
32		
33	SECTION 1: PURPOSE	
34	The purpose of this Compact is to facilitate interstate Practice of Dieter	ics
35	with the goal of improving public access to dietetics services. This Compa	ct
36	preserves the regulatory authority of States to protect public health and	

- 1 safety through the current system of State licensure, while also providing
- 2 for licensure portability through a Compact Privilege granted to qualifying
- 3 professionals.
- 4 This Compact is designed to achieve the following objectives:
- 5 A. Increase public access to dietetics services;
- 6 B. Provide opportunities for interstate practice by Licensed
- 7 Dietitians who meet uniform requirements;
- 8 C. Eliminate the necessity for Licenses in multiple States;
- 9 D. Reduce administrative burden on Member States and Licensees;
- 10 <u>E. Enhance the States' ability to protect the public's health and</u>
- 11 safety;
- ${\tt F.}$ Encourage the cooperation of Member States in regulating multistate
- 13 practice of Licensed Dietitians;
- 14 G. Support relocating Active Military Members and their spouses;
- 15 <u>H. Enhance the exchange of licensure, investigative, and disciplinary</u>
- 16 <u>information among Member States</u>; and
- 17 I. Vest all Member States with the authority to hold a Licensed
- 18 <u>Dietitian accountable for meeting all State practice laws in the State in</u>
- 19 which the patient is located at the time care is rendered.

- 21 SECTION 2. DEFINITIONS
- 22 As used in this Compact, and except as otherwise provided, the following
- 23 definitions shall apply:
- 24 A. "ACEND" means the Accreditation Council for Education in Nutrition
- 25 <u>and Dietetics or its successor organization.</u>
- 26 B. "Active Military Member" means any individual with full-time duty
- 27 status in the active armed forces of the United States, including members of
- 28 the National Guard and Reserve.
- 29 <u>C. "Adverse Action" means any administrative, civil, equitable or</u>
- 30 <u>criminal action permitted by a State's laws which is imposed by a Licensing</u>
- 31 <u>Authority or other authority against a Licensee, including actions against an</u>
- 32 individual's License or Compact Privilege such as revocation, suspension,
- 33 probation, monitoring of the Licensee, limitation on the Licensee's practice,
- 34 or any other Encumbrance on licensure affecting a Licensee's authorization to
- 35 practice, including issuance of a cease and desist action.
- 36 <u>D. "Alternative Program" means a non-disciplinary monitoring or</u>

- 1 practice remediation process approved by a Licensing Authority.
- 2 <u>E. "Charter Member State" means any Member State which enacted this</u>
- 3 Compact by law before the Effective Date specified in Section 12.
- F. "Continuing Education" means a requirement, as a condition of
- 5 License renewal, to provide evidence of participation in, and completion of,
- 6 educational and professional activities relevant to practice or area of work.
- 7 <u>G. "CDR" means the Commission on Dietetic Registration or its</u>
- 8 <u>successor organization</u>.
- 9 H. "Compact Commission" means the government agency whose membership
- 10 consists of all States that have enacted this Compact, which is known as the
- 11 <u>Dietitian Licensure Compact Commission</u>, as described in Section 8, and which
- 12 <u>shall operate as an instrumentality of the Member States.</u>
- 13 <u>I. "Compact Privilege" means a legal authorization, which is</u>
- 14 <u>equivalent to a License</u>, <u>permitting the Practice of Dietetics in a Remote</u>
- 15 State.
- 16 <u>J. "Current Significant Investigative Information" means:</u>
- 17 <u>l. Investigative Information that a Licensing Authority, after a</u>
- 18 preliminary inquiry that includes notification and an opportunity for the
- 19 <u>subject Licensee to respond, if required by State law, has reason to believe</u>
- 20 <u>is not groundless and, if proved true, would indicate more than a minor</u>
- 21 infraction; or
- 22 <u>2. Investigative Information that indicates that the subject</u>
- 23 Licensee represents an immediate threat to public health and safety
- 24 regardless of whether the subject Licensee has been notified and had an
- 25 <u>opportunity to respond.</u>
- 26 <u>K. "Data System" means a repository of information about Licensees,</u>
- 27 including, but not limited to, Continuing Education, examination, licensure,
- 28 investigative, Compact Privilege and Adverse Action information.
- 29 <u>L. "Encumbered License" means a License in which an Adverse Action</u>
- 30 <u>restricts a Licensee's ability to practice dietetics.</u>
- 31 M. "Encumbrance" means a revocation or suspension of, or any
- 32 limitation on a Licensee's full and unrestricted Practice of Dietetics by a
- 33 Licensing Authority.
- 34 N. "Executive Committee" means a group of delegates elected or
- 35 appointed to act on behalf of, and within the powers granted to them by, this
- 36 <u>Compact</u>, and the <u>Compact Commission</u>.

- 1 <u>O. "Home State" means the Member State that is the Licensee's primary</u> 2 State of residence or that has been designated pursuant to Section 6.
- 3 P. "Investigative Information" means information, records, and
- P. "Investigative Information" means information, records, and
- 4 <u>documents received or generated by a Licensing Authority pursuant to an</u> 5 investigation.
- 6 Q. "Jurisprudence Requirement" means an assessment of an individual's
- 7 knowledge of the State laws and regulations governing the Practice of
- 8 <u>Dietetics in such State.</u>
- 9 R. "License" means an authorization from a Member State to either:
- 10 <u>1. Engage in the Practice of Dietetics (including medical</u>
- 11 nutrition therapy); or
- 12 <u>2. Use the title "dietitian," "licensed dietitian," "licensed</u>
- 13 <u>dietitian nutritionist," "certified dietitian," or other title describing a</u>
- 14 <u>substantially similar practitioner as the Compact Commission may further</u>
- 15 <u>define by Rule.</u>
- S. "Licensee" or "Licensed Dietitian" means an individual who
- 17 <u>currently holds a License and who meets all of the requirements outlined in</u>
- 18 Section 4.
- 19 <u>T. "Licensing Authority" means the board or agency of a State, or</u>
- 20 equivalent, that is responsible for the licensing and regulation of the
- 21 Practice of Dietetics.
- 22 U. "Member State" means a State that has enacted the Compact.
- 23 V. "Practice of Dietetics" means the synthesis and application of
- 24 dietetics, primarily for the provision of nutrition care services, including
- 25 medical nutrition therapy, in person or via telehealth, to prevent, manage,
- 26 <u>or treat diseases or medical conditions and promote wellness.</u>
- W. "Registered Dietitian" means a person who:
- 28 1. Has completed applicable education, experience, examination,
- 29 and recertification requirements approved by CDR;
- 30 <u>2. Is credentialed by CDR as a registered dietitian or a</u>
- 31 <u>registered dietitian nutritionist; and</u>
- 32 3. Is legally authorized to use the title registered dietitian
- 33 or registered dietitian nutritionist and the corresponding abbreviations "RD"
- 34 or "RDN."
- 35 X. "Remote State" means a Member State other than the Home State,
- 36 where a Licensee is exercising or seeking to exercise a Compact Privilege.

1	Y. "Rule" means a regulation promulgated by the Compact Commission
2	that has the force of law.
3	Z. "Single State License" means a License issued by a Member State
4	within the issuing State and does not include a Compact Privilege in any
5	other Member State.
6	AA. "State" means any state, commonwealth, district, or territory of
7	the United States of America.
8	BB. "Unencumbered License" means a License that authorizes a Licensee
9	to engage in the full and unrestricted Practice of Dietetics.
10	
11	SECTION 3. STATE PARTICIPATION IN THE COMPACT
12	A. To participate in the Compact, a State must currently:
13	1. License and regulate the Practice of Dietetics; and
14	2. Have a mechanism in place for receiving and investigating
15	complaints about Licensees.
16	B. A Member State shall:
17	1. Participate fully in the Compact Commission's Data System,
18	including using the unique identifier as defined in Rules;
19	2. Notify the Compact Commission, in compliance with the terms
20	of the Compact and Rules, of any Adverse Action or the availability of
21	Current Significant Investigative Information regarding a Licensee;
22	3. Implement or utilize procedures for considering the criminal
23	history record information of applicants for an initial Compact Privilege.
24	These procedures shall include the submission of fingerprints or other
25	biometric-based information by applicants for the purpose of obtaining an
26	applicant's criminal history record information from the Federal Bureau of
27	Investigation and the agency responsible for retaining that State's criminal
28	records;
29	a. A Member State must fully implement a criminal history
30	record information requirement, within a time frame established by Rule,
31	which includes receiving the results of the Federal Bureau of Investigation
32	record search and shall use those results in determining Compact Privilege
33	eligibility.
34	b. Communication between a Member State and the Compact
35	Commission or among Member States regarding the verification of eligibility
36	for a Compact Privilege shall not include any information received from the

1	rederal bureau of investigation relating to a federal criminal history record
2	information check performed by a Member State.
3	4. Comply with and enforce the Rules of the Compact Commission;
4	5. Require an applicant for a Compact Privilege to obtain or
5	retain a License in the Licensee's Home State and meet the Home State's
6	qualifications for licensure or renewal of licensure, as well as all other
7	applicable State laws; and
8	6. Recognize a Compact Privilege granted to a Licensee who meets
9	all of the requirements outlined in Section 4 in accordance with the terms of
10	the Compact and Rules.
11	C. Member States may set and collect a fee for granting a Compact
12	Privilege.
13	D. Individuals not residing in a Member State shall continue to be
14	able to apply for a Member State's Single State License as provided under the
15	laws of each Member State. However, the Single State License granted to these
16	individuals shall not be recognized as granting a Compact Privilege to engage
17	in the Practice of Dietetics in any other Member State.
18	E. Nothing in this Compact shall affect the requirements established
19	by a Member State for the issuance of a Single State License.
20	F. At no point shall the Compact Commission have the power to define
21	the requirements for the issuance of a Single State License to practice
22	dietetics. The Member States shall retain sole jurisdiction over the
23	provision of these requirements.
24	
25	SECTION 4. COMPACT PRIVILEGE
26	A. To exercise the Compact Privilege under the terms and provisions of
27	the Compact, the Licensee shall:
28	1. Satisfy one of the following:
29	a. Hold a valid current registration that gives the
30	applicant the right to use the term Registered Dietitian; or
31	b. Complete all of the following:
32	i. An education program which is either:
33	a) A master's degree or doctoral degree that
34	is programmatically accredited by (i) ACEND; or (ii) a dietetics accrediting
35	agency recognized by the United States Department of Education, which the
36	Compact Commission may by Rule determine, and from a college or university

1 accredited at the time of graduation by the appropriate regional accrediting 2 agency recognized by the Council on Higher Education Accreditation and the United States Department of Education. 3 4 b) An academic degree from a college or 5 university in a foreign country equivalent to the degree described in 6 subparagraph (a) that is programmatically accredited by (i) ACEND; or (ii) a 7 dietetics accrediting agency recognized by the United States Department of Education, which the Compact Commission may by Rule determine. 8 9 ii. A planned, documented, supervised practice 10 experience in dietetics that is programmatically accredited by (i) ACEND, or (ii) a dietetics accrediting agency recognized by the United States 11 12 Department of Education which the Compact Commission may by Rule determine 13 and which involves at least 1000 hours of practice experience under the 14 supervision of a Registered Dietitian or a Licensed Dietitian. 15 iii. Successful completion of either: (i) the 16 Registration Examination for Dietitians administered by CDR, or (ii) a 17 national credentialing examination for dietitians approved by the Compact Commission by Rule; such completion being no more than five years prior to 18 19 the date of the Licensee's application for initial licensure and accompanied 20 by a period of continuous licensure thereafter, all of which may be further governed by the Rules of the Compact Commission. 21 22 2. Hold an Unencumbered License in the Home State; 23 3. Notify the Compact Commission that the Licensee is seeking a 24 Compact Privilege within a Remote State(s); 25 4. Pay any applicable fees, including any State fee, for the 26 Compact Privilege; 27 5. Meet any Jurisprudence Requirements established by the Remote 28 State(s) in which the Licensee is seeking a Compact Privilege; and 29 6. Report to the Compact Commission any Adverse Action, 30 Encumbrance, or restriction on a License taken by any non-Member State within 31 30 days from the date the action is taken. 32 B. The Compact Privilege is valid until the expiration date of the Home State License. To maintain a Compact Privilege, renewal of the Compact 33 34 Privilege shall be congruent with the renewal of the Home State License as

the Compact Commission may define by Rule. The Licensee must comply with the

requirements of Section 4(A) to maintain the Compact Privilege in the Remote

35

- 1 State(s). 2 C. A Licensee exercising a Compact Privilege shall adhere to the laws 3 and regulations of the Remote State. Licensees shall be responsible for 4 educating themselves on, and complying with, any and all State laws relating 5 to the Practice of Dietetics in such Remote State. 6 D. Notwithstanding anything to the contrary provided in this Compact 7 or State law, a Licensee exercising a Compact Privilege shall not be required 8 to complete Continuing Education Requirements required by a Remote State. A 9 Licensee exercising a Compact Privilege is only required to meet any 10 Continuing Education Requirements as required by the Home State. 11 12 SECTION 5: OBTAINING A NEW HOME STATE LICENSE BASED ON A COMPACT PRIVILEGE 13 A. A Licensee may hold a Home State License, which allows for a Compact Privilege in other Member States, in only one Member State at a time. 14 15 B. If a Licensee changes Home State by moving between two Member 16 States: 17 1. The Licensee shall file an application for obtaining a new 18 Home State License based on a Compact Privilege, pay all applicable fees, and 19 notify the current and new Home State in accordance with the Rules of the 20 Compact Commission. 21 2. Upon receipt of an application for obtaining a new Home State 22 License by virtue of a Compact Privilege, the new Home State shall verify 23 that the Licensee meets the criteria in Section 4 via the Data System, and 24 require that the Licensee complete the following: 25 a. Federal Bureau of Investigation fingerprint based 26 criminal history record information check; 27 b. Any other criminal history record information required 28 by the new Home State; and 29 c. Any Jurisprudence Requirements of the new Home State. 30 3. The former Home State shall convert the former Home State 31 License into a Compact Privilege once the new Home State has activated the 32 new Home State License in accordance with applicable Rules adopted by the
- 4. Notwithstanding any other provision of this Compact, if the
 Licensee cannot meet the criteria in Section 4, the new Home State may apply
 its requirements for issuing a new Single State License.

Compact Commission.

1 5. The Licensee shall pay all applicable fees to the new Home 2 State in order to be issued a new Home State License. 3 C. If a Licensee changes their State of residence by moving from a 4 Member State to a non-Member State, or from a non-Member State to a Member 5 State, the State criteria shall apply for issuance of a Single State License 6 in the new State. 7 D. Nothing in this Compact shall interfere with a Licensee's ability 8 to hold a Single State License in multiple States; however, for the purposes 9 of this Compact, a Licensee shall have only one Home State License. 10 E. Nothing in this Compact shall affect the requirements established by a Member State for the issuance of a Single State License. 11 12 SECTION 6. ACTIVE MILITARY MEMBERS OR THEIR SPOUSES 13 An Active Military Member, or their spouse, shall designate a Home State 14 15 where the individual has a current License in good standing. The individual 16 may retain the Home State designation during the period the service member is 17 on active duty. 18 19 SECTION 7. ADVERSE ACTIONS 20 A. In addition to the other powers conferred by State law, a Remote State shall have the authority, in accordance with existing State due process 21 22 law, to: 23 1. Take Adverse Action against a Licensee's Compact Privilege 24 within that Member State; and 25 2. Issue subpoenas for both hearings and investigations that 26 require the attendance and testimony of witnesses as well as the production 27 of evidence. Subpoenas issued by a Licensing Authority in a Member State for 28 the attendance and testimony of witnesses or the production of evidence from 29 another Member State shall be enforced in the latter State by any court of 30 competent jurisdiction, according to the practice and procedure applicable to subpoenas issued in proceedings pending before that court. The issuing 31 32 authority shall pay any witness fees, travel expenses, mileage, and other fees required by the service statutes of the State in which the witnesses or 33 34 evidence are located. B. Only the Home State shall have the power to take Adverse Action 35

against a Licensee's Home State License.

- 1 C. For purposes of taking Adverse Action, the Home State shall give
- 2 <u>the same priority and effect to reported conduct received from a Member State</u>
- 3 as it would if the conduct had occurred within the Home State. In so doing,
- 4 the Home State shall apply its own State laws to determine appropriate
- 5 action.
- 6 D. The Home State shall complete any pending investigations of a
- 7 Licensee who changes Home States during the course of the investigations. The
- 8 Home State shall also have authority to take appropriate action(s) and shall
- 9 promptly report the conclusions of the investigations to the administrator of
- 10 <u>the Data System. The administrator of the Data System shall promptly notify</u>
- 11 the new Home State of any Adverse Actions.
- E. A Member State, if otherwise permitted by State law, may recover
- 13 <u>from the affected Licensee the costs of investigations and dispositions of</u>
- 14 <u>cases resulting from any Adverse Action taken against that Licensee.</u>
- 15 F. A Member State may take Adverse Action based on the factual
- 16 findings of another Remote State, provided that the Member State follows its
- 17 own procedures for taking the Adverse Action.
- 18 <u>G. Joint Investigations:</u>
- 19 <u>l. In addition to the authority granted to a Member State by its</u>
- 20 <u>respective State law, any Member State may participate with other Member</u>
- 21 States in joint investigations of Licensees.
- 22 2. Member States shall share any investigative, litigation, or
- 23 compliance materials in furtherance of any joint investigation initiated
- 24 <u>under the Compact.</u>
- 25 <u>H. If Adverse Action is taken by the Home State against a Licensee's</u>
- 26 Home State License resulting in an Encumbrance on the Home State License, the
- 27 Licensee's Compact Privilege(s) in all other Member States shall be revoked
- 28 until all Encumbrances have been removed from the Home State License. All
- 29 Home State disciplinary orders that impose Adverse Action against a Licensee
- 30 <u>shall include a statement that the Licensee's Compact Privileges are revoked</u>
- 31 <u>in all Member States during the pendency of the order.</u>
- 32 I. Once an Encumbered License in the Home State is restored to an
- 33 Unencumbered License (as certified by the Home State's Licensing Authority),
- 34 the Licensee must meet the requirements of Section 4(A) and follow the
- 35 administrative requirements to reapply to obtain a Compact Privilege in any
- 36 <u>Remote State.</u>

1	J. If a Member State takes Adverse Action, it shall promptly notify
2	the administrator of the Data System. The administrator of the Data System
3	shall promptly notify the other Member States State of any Adverse Actions.
4	K. Nothing in this Compact shall override a Member State's decision
5	that participation in an Alternative Program may be used in lieu of Adverse
6	Action.
7	
8	SECTION 8. ESTABLISHMENT OF THE DIETITIAN LICENSURE COMPACT COMMISSION
9	A. The Compact Member States hereby create and establish a joint
10	government agency whose membership consists of all Member States that have
11	enacted the Compact known as the Dietitian Licensure Compact Commission. The
12	Compact Commission is an instrumentality of the Compact States acting jointly
13	and not an instrumentality of any one State. The Compact Commission shall
14	come into existence on or after the effective date of the Compact as set
15	forth in Section 12.
16	B. Membership, Voting, and Meetings
17	1. Each Member State shall have and be limited to one (1)
18	delegate selected by that Member State's Licensing Authority.
19	2. The delegate shall be the primary administrator of the
20	Licensing Authority or their designee.
21	3. The Compact Commission shall by Rule or bylaw establish a
22	term of office for delegates and may by Rule or bylaw establish term limits.
23	4. The Compact Commission may recommend removal or suspension of
24	any delegate from office.
25	5. A Member State's Licensing Authority shall fill any vacancy
26	of its delegate occurring on the Compact Commission within 60 days of the
27	vacancy.
28	6. Each delegate shall be entitled to one vote on all matters
29	before the Compact Commission requiring a vote by the delegates.
30	7. Delegates shall meet and vote by such means as set forth in
31	the bylaws. The bylaws may provide for delegates to meet and vote in-person
32	or by telecommunication, video conference, or other means of communication.
33	8. The Compact Commission shall meet at least once during each
34	calendar year. Additional meetings may be held as set forth in the bylaws.
35	The Compact Commission may meet in person or by telecommunication, video
36	conference or other means of communication

1	C. The Compact Commission shall have the following powers:
2	1. Establish the fiscal year of the Compact Commission;
3	2. Establish code of conduct and conflict of interest policies;
4	3. Establish and amend Rules and bylaws;
5	4. Maintain its financial records in accordance with the bylaws;
6	5. Meet and take such actions as are consistent with the
7	provisions of this Compact, the Compact Commission's Rules, and the bylaws;
8	6. Initiate and conclude legal proceedings or actions in the
9	name of the Compact Commission, provided that the standing of any Licensing
10	Authority to sue or be sued under applicable law shall not be affected;
11	7. Maintain and certify records and information provided to a
12	Member State as the authenticated business records of the Compact Commission,
13	and designate an agent to do so on the Compact Commission's behalf;
14	8. Purchase and maintain insurance and bonds;
15	9. Borrow, accept, or contract for services of personnel,
16	including, but not limited to, employees of a Member State;
17	10. Conduct an annual financial review;
18	11. Hire employees, elect or appoint officers, fix compensation,
19	define duties, grant such individuals appropriate authority to carry out the
20	purposes of the Compact, and establish the Compact Commission's personnel
21	policies and programs relating to conflicts of interest, qualifications of
22	personnel, and other related personnel matters;
23	12. Assess and collect fees;
24	13. Accept any and all appropriate donations, grants of money,
25	other sources of revenue, equipment, supplies, materials, services, and
26	gifts, and receive, utilize, and dispose of the same; provided that at all
27	times the Compact Commission shall avoid any actual or appearance of
28	<pre>impropriety or conflict of interest;</pre>
29	14. Lease, purchase, retain, own, hold, improve, or use any
30	property, real, personal, or mixed, or any undivided interest therein;
31	15. Sell, convey, mortgage, pledge, lease, exchange, abandon, or
32	otherwise dispose of any property real, personal, or mixed;
33	16. Establish a budget and make expenditures;
34	17. Borrow money;
35	18. Appoint committees, including standing committees, composed
36	of members, State regulators, State legislators or their representatives, and

1	consumer representatives, and such other interested persons as may be
2	designated in this Compact or the bylaws;
3	19. Provide and receive information from, and cooperate with,
4	<pre>law enforcement agencies;</pre>
5	20. Establish and elect an Executive Committee, including a
6	chair and a vice chair;
7	21. Determine whether a State's adopted language is materially
8	different from the model compact language such that the State would not
9	qualify for participation in the Compact; and
10	22. Perform such other functions as may be necessary or
11	appropriate to achieve the purposes of this Compact.
12	D. The Executive Committee
13	1. The Executive Committee shall have the power to act on behalf
14	of the Compact Commission according to the terms of this Compact. The powers,
15	duties, and responsibilities of the Executive Committee shall include:
16	a. Oversee the day-to-day activities of the administration
17	of the Compact including enforcement and compliance with the provisions of
18	the Compact, its Rules and bylaws, and other such duties as deemed necessary;
19	b. Recommend to the Compact Commission changes to the
20	Rules or bylaws, changes to this Compact legislation, fees charged to Compact
21	Member States, fees charged to Licensees, and other fees;
22	c. Ensure Compact administration services are
23	appropriately provided, including by contract;
24	d. Prepare and recommend the budget;
25	e. Maintain financial records on behalf of the Compact
26	Commission;
27	f. Monitor Compact compliance of Member States and provide
28	compliance reports to the Compact Commission;
29	g. Establish additional committees as necessary;

1	2. The Executive Committee shall be composed of nine members:
2	a. The chair and vice chair of the Compact Commission
3	shall be voting members of the Executive Committee;
4	b. Five voting members from the current membership of the
5	Compact Commission, elected by the Compact Commission;
6	c. One ex-officio, nonvoting member from a recognized
7	professional association representing dietitians; and
8	d. One ex-officio, nonvoting member from a recognized
9	national credentialing organization for dietitians.
10	3. The Compact Commission may remove any member of the Executive
11	Committee as provided in the Compact Commission's bylaws.
12	4. The Executive Committee shall meet at least annually.
13	a. Executive Committee meetings shall be open to the
14	public, except that the Executive Committee may meet in a closed, non-public
15	meeting as provided in subsection (F)(2).
16	b. The Executive Committee shall give 30 days' notice of
17	its meetings, posted on the website of the Compact Commission and as
18	determined to provide notice to persons with an interest in the business of
19	the Compact Commission.
20	c. The Executive Committee may hold a special meeting in
21	accordance with subsection (F)(1)(b).
22	E. The Compact Commission shall adopt and provide to the Member States
23	an annual report.
24	F. Meetings of the Compact Commission
25	1. All meetings shall be open to the public, except that the
26	Compact Commission may meet in a closed, non-public meeting as provided in
27	subsection (F)(2).
28	a. Public notice for all meetings of the full Compact
29	Commission shall be given in the same manner as required under the rulemaking
30	provisions in Section 10, except that the Compact Commission may hold a
31	special meeting as provided in subsection (F)(1)(b).
32	b. The Compact Commission may hold a special meeting when
33	it must meet to conduct emergency business by giving 24 hours' notice to all
34	Member States, on the Compact Commission's website, and other means as
35	provided in the Compact Commission's Rules. The Compact Commission's legal
36	counsel shall certify that the Compact Commission's need to meet qualifies as

1	an emergency.
2	2. The Compact Commission or the Executive Committee or other
3	committees of the Compact Commission may convene in a closed, non-public
4	meeting for the Compact Commission or Executive Committee or other committees
5	of the Compact Commission to receive legal advice or to discuss:
6	a. Non-compliance of a Member State with its obligations
7	under the Compact;
8	b. The employment, compensation, discipline, or other
9	matters, practices, or procedures related to specific employees;
10	c. Current or threatened discipline of a Licensee by the
11	Compact Commission or by a Member State's Licensing Authority;
12	d. Current, threatened, or reasonably anticipated
13	litigation;
14	e. Negotiation of contracts for the purchase, lease, or
15	sale of goods, services, or real estate;
16	f. Accusing any person of a crime or formally censuring
17	any person;
18	g. Trade secrets or commercial or financial information
19	that is privileged or confidential;
20	h. Information of a personal nature where disclosure would
21	constitute a clearly unwarranted invasion of personal privacy;
22	i. Investigative records compiled for law enforcement
23	purposes;
24	j. Information related to any investigative reports
25	prepared by or on behalf of or for use of the Compact Commission or other
26	committee charged with responsibility of investigation or determination of
27	compliance issues pursuant to the Compact;
28	k. Matters specifically exempted from disclosure by
29	federal or Member State law; or
30	1. Other matters as specified in the Rules of the Compact
31	Commission.
32	3. If a meeting, or portion of a meeting, is closed, the
33	presiding officer shall state that the meeting will be closed and reference
34	each relevant exempting provision, and such reference shall be recorded in
35	the minutes.
36	4. The Compact Commission shall keep minutes that fully and

- 1 clearly describe all matters discussed in a meeting and shall provide a full
- 2 and accurate summary of actions taken, and the reasons therefore, including a
- 3 description of the views expressed. All documents considered in connection
- 4 with an action shall be identified in such minutes. All minutes and documents
- 5 of a closed meeting shall remain under seal, subject to release only by a
- 6 majority vote of the Compact Commission or order of a court of competent
- 7 jurisdiction.
 - G. Financing of the Compact Commission
- 9 1. The Compact Commission shall pay, or provide for the payment
- 10 of, the reasonable expenses of its establishment, organization, and ongoing
- ll activities.

- 12 <u>2. The Compact Commission may accept any and all appropriate</u>
- 13 revenue sources as provided in subsection (C)(13).
- 14 <u>3. The Compact Commission may levy on and collect an annual</u>
- 15 <u>assessment from each Member State and impose fees on Licensees of Member</u>
- 16 States to whom it grants a Compact Privilege to cover the cost of the
- 17 operations and activities of the Compact Commission and its staff, which
- 18 must, in a total amount, be sufficient to cover its annual budget as approved
- 19 <u>each year for which revenue is not provided by other sources. The aggregate</u>
- 20 <u>annual assessment amount for Member States shall be allocated based upon a</u>
- 21 formula that the Compact Commission shall promulgate by Rule.
- 22 <u>4. The Compact Commission shall not incur obligations of any</u>
- 23 kind prior to securing the funds adequate to meet the same; nor shall the
- 24 Compact Commission pledge the credit of any of the Member States, except by
- 25 and with the authority of the Member State.
- 26 <u>5. The Compact Commission shall keep accurate accounts of all</u>
- 27 receipts and disbursements. The receipts and disbursements of the Compact
- 28 Commission shall be subject to the financial review and accounting procedures
- 29 <u>established under its bylaws. However, all receipts and disbursements of</u>
- 30 <u>funds handled by the Compact Commission shall be subject to an annual</u>
- 31 financial review by a certified or licensed public accountant, and the report
- 32 of the financial review shall be included in and become part of the annual
- 33 report of the Compact Commission.
- 34 H. Qualified Immunity, Defense, and Indemnification
- 35 <u>1. The members, officers, executive director, employees and</u>
- 36 representatives of the Compact Commission shall be immune from suit and

- liability, both personally and in their official capacity, for any claim for
- 2 damage to or loss of property or personal injury or other civil liability
- 3 <u>caused by or arising out of any actual or alleged act, error, or omission</u>
- 4 that occurred, or that the person against whom the claim is made had a
- 5 reasonable basis for believing occurred within the scope of Compact
- 6 Commission employment, duties, or responsibilities; provided that nothing in
- 7 this paragraph shall be construed to protect any such person from suit or
- 8 liability for any damage, loss, injury, or liability caused by the
- 9 intentional or willful or wanton misconduct of that person. The procurement
- 10 of insurance of any type by the Compact Commission shall not in any way
- 11 compromise or limit the immunity granted hereunder.
- 12 <u>2. The Compact Commission shall defend any member, officer,</u>
- 13 executive director, employee, and representative of the Compact Commission
- 14 in any civil action seeking to impose liability arising out of any actual or
- 15 <u>alleged act, error, or omission that occurred within the scope of Compact</u>
- 16 Commission employment, duties, or responsibilities, or as determined by the
- 17 Compact Commission that the person against whom the claim is made had a
- 18 <u>reasonable basis for believing occurred within the scope of Compact</u>
- 19 <u>Commission employment, duties, or responsibilities; provided that nothing</u>
- 20 <u>herein shall be construed to prohibit that person from retaining their own</u>
- 21 counsel at their own expense; and provided further, that the actual or
- 22 alleged act, error, or omission did not result from that person's intentional
- 23 or willful or wanton misconduct.
- 24 3. The Compact Commission shall indemnify and hold harmless any
- 25 member, officer, executive director, employee, and representative of the
- 26 Compact Commission for the amount of any settlement or judgment obtained
- 27 against that person arising out of any actual or alleged act, error, or
- 28 omission that occurred within the scope of Compact Commission employment,
- 29 <u>duties</u>, or responsibilities, or that such person had a reasonable basis for
- 30 believing occurred within the scope of Compact Commission employment, duties,
- 31 or responsibilities, provided that the actual or alleged act, error, or
- 32 omission did not result from the intentional or willful or wanton misconduct
- 33 of that person.
- 34 4. Nothing herein shall be construed as a limitation on the
- 35 liability of any Licensee for professional malpractice or misconduct, which
- 36 <u>shall be governed solely by any other applicable State laws.</u>

1	5. Nothing in this Compact shall be interpreted to waive or
2	otherwise abrogate a Member State's state action immunity or state action
3	affirmative defense with respect to antitrust claims under the Sherman Act,
4	Clayton Act, or any other State or federal antitrust or anticompetitive law
5	or regulation.
6	6. Nothing in this Compact shall be construed to be a waiver of
7	sovereign immunity by the Member States or by the Compact Commission.
8	
9	SECTION 9. DATA SYSTEM
10	A. The Compact Commission shall provide for the development,
11	maintenance, operation, and utilization of a coordinated Data System.
12	B. The Compact Commission shall assign each applicant for a Compact
13	Privilege a unique identifier, as determined by the Rules.
14	C. Notwithstanding any other provision of State law to the contrary, a
15	Member State shall submit a uniform data set to the Data System on all
16	individuals to whom this Compact is applicable as required by the Rules of
17	the Compact Commission, including:
18	<pre>1. Identifying information;</pre>
19	2. Licensure data;
20	3. Adverse Actions against a License or Compact Privilege and
21	information related thereto;
22	4. Non-confidential information related to Alternative Program
23	participation, the beginning and ending dates of such participation, and
24	other information related to such participation not made confidential under
25	Member State law;
26	5. Any denial of application for licensure, and the reason(s)
27	for such denial;
28	6. The presence of Current Significant Investigative
29	Information; and
30	7. Other information that may facilitate the administration of
31	this Compact or the protection of the public, as determined by the Rules of
32	the Compact Commission.
33	D. The records and information provided to a Member State pursuant to
34	this Compact or through the Data System, when certified by the Compact
35	Commission or an agent thereof, shall constitute the authenticated business
36	records of the Compact Commission, and shall be entitled to any associated

- hearsay exception in any relevant judicial, quasi-judicial, or administrative proceedings in a Member State.
- 3 <u>E. Current Significant Investigative Information pertaining to a</u>
 4 Licensee in any Member State will only be available to other Member States.
- 5 <u>F. It is the responsibility of the Member States to report any Adverse</u> 6 <u>Action against a Licensee and to monitor the Data System to determine whether</u>
- 7 any Adverse Action has been taken against a Licensee. Adverse Action
- 8 <u>information pertaining to a Licensee in any Member State will be available to</u> 9 any other Member State.
- G. Member States contributing information to the Data System may
 designate information that may not be shared with the public without the
 express permission of the contributing State.
- H. Any information submitted to the Data System that is subsequently
 expunged pursuant to federal law or the laws of the Member State contributing
 the information shall be removed from the Data System.

SECTION 10. RULEMAKING

- A. The Compact Commission shall promulgate reasonable Rules in order
 to effectively and efficiently implement and administer the purposes and
 provisions of the Compact. A Rule shall be invalid and have no force or
 effect only if a court of competent jurisdiction holds that the Rule is
 invalid because the Compact Commission exercised its rulemaking authority in
 a manner that is beyond the scope and purposes of the Compact, or the powers
 granted hereunder, or based upon another applicable standard of review.
 - B. The Rules of the Compact Commission shall have the force of law in each Member State, provided however that where the Rules conflict with the laws or regulations of a Member State that relate to the procedures, actions, and processes a Licensed Dietitian is permitted to undertake in that State and the circumstances under which they may do so, as held by a court of competent jurisdiction, the Rules of the Compact Commission shall be ineffective in that State to the extent of the conflict.
- C. The Compact Commission shall exercise its rulemaking powers

 pursuant to the criteria set forth in this Section and the Rules adopted

 thereunder. Rules shall become binding on the day following adoption or as of

 the date specified in the Rule or amendment, whichever is later.
 - D. If a majority of the legislatures of the Member States rejects a

- 1 Rule or portion of a Rule, by enactment of a statute or resolution in the
- 2 same manner used to adopt the Compact within four (4) years of the date of
- 3 <u>adoption of the Rule</u>, then such Rule shall have no further force and effect
- 4 in any Member State.
- 5 <u>E. Rules shall be adopted at a regular or special meeting of the</u>
- 6 Compact Commission.
- 7 F. Prior to adoption of a proposed Rule, the Compact Commission shall
- 8 hold a public hearing and allow persons to provide oral and written comments,
- 9 data, facts, opinions, and arguments.
- 10 G. Prior to adoption of a proposed Rule by the Compact Commission, and
- 11 at least thirty (30) days in advance of the meeting at which the Compact
- 12 <u>Commission will hold a public hearing on the proposed Rule, the Compact</u>
- 13 Commission shall provide a Notice of Proposed rulemaking:
- 1. On the website of the Compact Commission or other publicly
- 15 <u>accessible platform;</u>
- 16 <u>2. To persons who have requested notice of the Compact</u>
- 17 Commission's notices of proposed rulemaking; and
- 18 <u>3. In such other way(s) as the Compact Commission may by Rule</u>
- 19 specify.
- 20 <u>H. The Notice of Proposed rulemaking shall include:</u>
- 21 <u>1. The time, date, and location of the public hearing at which</u>
- 22 the Compact Commission will hear public comments on the proposed Rule and, if
- 23 different, the time, date, and location of the meeting where the Compact
- 24 Commission will consider and vote on the proposed Rule;
- 25 <u>2. If the hearing is held via telecommunication, video</u>
- 26 <u>conference</u>, or other means of communication, the Compact Commission shall
- 27 <u>include the mechanism for access to the hearing in the Notice of Proposed</u>
- 28 rulemaking;
- 29 3. The text of the proposed Rule and the reason therefore;
- 30 <u>4. A request for comments on the proposed Rule from any</u>
- 31 <u>interested person; and</u>
- 32 5. The manner in which interested persons may submit written
- 33 comments.
- 34 I. All hearings will be recorded. A copy of the recording and all
- 35 written comments and documents received by the Compact Commission in response
- 36 to the proposed Rule shall be available to the public.

1	J. Nothing in this Section shall be construed as requiring a separate
2	hearing on each Rule. Rules may be grouped for the convenience of the Compact
3	Commission at hearings required by this Section.
4	K. The Compact Commission shall, by majority vote of all members, take
5	final action on the proposed Rule based on the rulemaking record and the full
6	text of the Rule.
7	1. The Compact Commission may adopt changes to the proposed Rule
8	provided the changes do not enlarge the original purpose of the proposed
9	Rule.
10	2. The Compact Commission shall provide an explanation of the
11	reasons for substantive changes made to the proposed Rule as well as reasons
12	for substantive changes not made that were recommended by commenters.
13	3. The Compact Commission shall determine a reasonable effective
14	date for the Rule. Except for an emergency as provided in Section 10(L), the
15	effective date of the Rule shall be no sooner than 30 days after issuing the
16	notice that it adopted or amended the Rule.
17	L. Upon determination that an emergency exists, the Compact Commission
18	may consider and adopt an emergency Rule with 24 hours' notice, with
19	opportunity to comment, provided that the usual rulemaking procedures
20	provided in the Compact and in this Section shall be retroactively applied to
21	the Rule as soon as reasonably possible, in no event later than ninety
22	(90) days after the effective date of the Rule. For the purposes of this
23	provision, an emergency Rule is one that must be adopted immediately in order
24	to:
25	1. Meet an imminent threat to public health, safety, or welfare;
26	2. Prevent a loss of Compact Commission or Member State funds;
27	3. Meet a deadline for the promulgation of a Rule that is
28	established by federal law or rule; or
29	4. Protect public health and safety.
30	M. The Compact Commission or an authorized committee of the Compact
31	Commission may direct revision to a previously adopted Rule for purposes of
32	correcting typographical errors, errors in format, errors in consistency, or
33	grammatical errors. Public notice of any revision shall be posted on the
34	website of the Compact Commission. The revision shall be subject to challenge
35	by any person for a period of thirty (30) days after posting. The revision

may be challenged only on grounds that the revision results in a material

- l change to a Rule. A challenge shall be made in writing and delivered to the
- 2 Compact Commission prior to the end of the notice period. If no challenge is
- 3 made, the revision will take effect without further action. If the revision
- 4 <u>is challenged</u>, the revision may not take effect without the approval of the
- 5 Compact Commission.
- N. No Member State's rulemaking requirements shall apply under this
- 7 <u>Compact.</u>

- SECTION 11. OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT
- 10 A. Oversight
- 11 <u>1. The executive and judicial branches of State government in</u>
- 12 <u>each Member State shall enforce this Compact and take all actions necessary</u>
- and appropriate to implement this Compact.
- 2. Except as otherwise provided in this Compact, venue is proper
- 15 and judicial proceedings by or against the Compact Commission shall be
- 16 brought solely and exclusively in a court of competent jurisdiction where the
- 17 principal office of the Compact Commission is located. The Compact Commission
- 18 may waive venue and jurisdictional defenses to the extent it adopts or
- 19 consents to participate in alternative dispute resolution proceedings.
- 20 Nothing herein shall affect or limit the selection or propriety of venue in
- 21 any action against a Licensee for professional malpractice, misconduct, or
- 22 any such similar matter.
- 23 3. The Compact Commission shall be entitled to receive service
- 24 of process in any proceeding regarding the enforcement or interpretation of
- 25 the Compact and shall have standing to intervene in such a proceeding for all
- 26 purposes. Failure to provide the Compact Commission service of process shall
- 27 render a judgment or order void as to the Compact Commission, this Compact,
- 28 or promulgated Rules.
- 29 B. Default, Technical Assistance, and Termination
- 1. If the Compact Commission determines that a Member State has
- 31 <u>defaulted in the performance of its obligations or responsibilities under</u>
- 32 <u>this Compact or the promulgated Rules, the Compact Commission shall provide</u>
- 33 written notice to the defaulting State. The notice of default shall describe
- 34 the default, the proposed means of curing the default, and any other action
- 35 that the Compact Commission may take and shall offer training and specific
- 36 <u>technical assistance regarding the default.</u>

- 1 <u>2. The Compact Commission shall provide a copy of the notice of</u> 2 default to the other Member States.
- 3 <u>C. If a State in default fails to cure the default, the defaulting</u>
- 4 State may be terminated from the Compact upon an affirmative vote of a
- 5 majority of the delegates of the Member States, and all rights, privileges,
- 6 and benefits conferred on that State by this Compact may be terminated
- 7 on the effective date of termination. A cure of the default does not relieve
- 8 the offending State of obligations or liabilities incurred during the period
- 9 of default.
- 10 D. Termination of membership in the Compact shall be imposed only
- 11 after all other means of securing compliance have been exhausted. Notice of
- 12 <u>intent to suspend or terminate shall be given by the Compact Commission to</u>
- 13 the governor, the majority and minority leaders of the defaulting State's
- 14 legislature, the defaulting State's Licensing Authority, and each of the
- 15 <u>Member States' Licensing Authority.</u>
- 16 E. A State that has been terminated is responsible for all
- 17 <u>assessments</u>, obligations, and liabilities incurred through the effective date
- 18 of termination, including obligations that extend beyond the effective date
- 19 of termination.
- 20 F. Upon the termination of a State's membership from this Compact,
- 21 that State shall immediately provide notice to all Licensees within that
- 22 State of such termination. The terminated State shall continue to recognize
- 23 all Compact Privileges granted pursuant to this Compact for a minimum of six
- 24 months after the date of said notice of termination.
- 25 <u>G. The Compact Commission shall not bear any costs related to a State</u>
- 26 that is found to be in default or that has been terminated from the Compact,
- 27 <u>unless agreed upon in writing between the Compact Commission and the</u>
- 28 defaulting State.
- 29 <u>H. The defaulting State may appeal the action of the Compact</u>
- 30 <u>Commission by petitioning the U.S. District Court for the District of</u>
- 31 <u>Columbia or the federal district where the Compact Commission has its</u>
- 32 principal offices. The prevailing party shall be awarded all costs of such
- 33 litigation, including reasonable attorney's fees.
- 34 I. Dispute Resolution
- 1. Upon request by a Member State, the Compact Commission shall
- 36 attempt to resolve disputes related to the Compact that arise among Member

2	2. The Compact Commission shall promulgate a Rule providing for
3	both mediation and binding dispute resolution for disputes as appropriate.
4	J. Enforcement
5	1. By supermajority vote, the Compact Commission may initiate
6	<u>legal</u> action against a Member State in default in the United States District
7	Court for the District of Columbia or the federal district where the Compact
8	Commission has its principal offices to enforce compliance with the
9	provisions of the Compact and its promulgated Rules. The relief sought may
10	include both injunctive relief and damages. In the event judicial enforcement
11	is necessary, the prevailing party shall be awarded all costs of such
12	litigation, including reasonable attorney's fees. The remedies herein shall
13	not be the exclusive remedies of the Compact Commission. The Compact
14	Commission may pursue any other remedies available under federal or the
15	defaulting Member State's law.
16	2. A Member State may initiate legal action against the Compact
17	Commission in the U.S. District Court for the District of Columbia or the
18	federal district where the Compact Commission has its principal offices to
19	enforce compliance with the provisions of the Compact and its promulgated
20	Rules. The relief sought may include both injunctive relief and damages. In
21	the event judicial enforcement is necessary, the prevailing party shall be
22	awarded all costs of such litigation, including reasonable attorney's fees.
23	3. No party other than a Member State shall enforce this Compact
24	against the Compact Commission.
25	
26	SECTION 12. EFFECTIVE DATE, WITHDRAWAL, AND AMENDMENT
27	A. The Compact shall come into effect on the date on which the Compact
28	statute is enacted into law in the seventh Member State.
29	1. On or after the effective date of the Compact, the Compact
30	Commission shall convene and review the enactment of each of the first seven
31	Member States ("Charter Member States") to determine if the statute enacted
32	by each such Charter Member State is materially different than the model
33	Compact statute.
34	a. A Charter Member State whose enactment is found to be
35	materially different from the model Compact statute shall be entitled to the
36	default process set forth in Section 11.

12	to the effective date of the Compact or the Compact Commission coming into
13	existence shall be considered to be actions of the Compact Commission unless
14	specifically repudiated by the Compact Commission.
15	4. Any State that joins the Compact subsequent to the Compact
16	Commission's initial adoption of the Rules and bylaws shall be subject to the
17	Rules and bylaws as they exist on the date on which the Compact becomes law
18	in that State. Any Rule that has been previously adopted by the Compact
19	Commission shall have the full force and effect of law on the day the Compact
20	becomes law in that State.
21	B. Any Member State may withdraw from this Compact by enacting a
22	statute repealing the same.
23	1. A Member State's withdrawal shall not take effect until 180
24	days after enactment of the repealing statute.
25	2. Withdrawal shall not affect the continuing requirement of the
26	withdrawing State's Licensing Authority to comply with the investigative and
27	Adverse Action reporting requirements of this Compact prior to the effective
28	date of withdrawal.
29	3. Upon the enactment of a statute withdrawing from this
30	Compact, a State shall immediately provide notice of such withdrawal to all
31	Licensees within that State. Notwithstanding any subsequent statutory

The provisions of this Compact shall be severable and if any 15 phrase, clause, sentence, or provision of this Compact is held by a court of 16 competent jurisdiction to be contrary to the constitution of any Member 17 State, a State seeking participation in the Compact, or of the United States, 18 or the applicability thereof to any government, agency, person, or 19 circumstance is held to be unconstitutional by a court of competent 20 jurisdiction, the validity of the remainder of this Compact and the 21 applicability thereof to any other government, agency, person, or 22 circumstance shall not be affected thereby. 23 C. Notwithstanding Section 13(B), the Compact Commission may deny a 24 State's participation in the Compact or, in accordance with the requirements 25 of Section 11(B), terminate a Member State's participation in the Compact, if 26 it determines that a constitutional requirement of a Member State is a 27 material departure from the Compact. Otherwise, if this Compact shall be held to be contrary to the constitution of any Member State, the Compact shall 28 29 remain in full force and effect as to the remaining Member States and in full 30 force and effect as to the Member State affected as to all severable matters. 31 32 SECTION 14. CONSISTENT EFFECT AND CONFLICT WITH OTHER STATE LAWS A. Nothing herein shall prevent or inhibit the enforcement of any 33 34 other law of a Member State that is not inconsistent with the Compact. 35 B. Any laws, statutes, regulations, or other legal requirements in a

Member State in conflict with the Compact are superseded to the extent of the

1	conflict.
2	C. All permissible agreements between the Compact Commission and the
3	Member States are binding in accordance with their terms.

6	(a) The Arkansas Dietetics Licensing Board is the Dietitian Licensure
7	Compact administrator for this state.
8	(b) The board may adopt rules that are consistent with the compact
9	necessary to implement this subchapter.
10	(c) The board is not required to adopt the rules of the Dietitian
11	Licensure Compact Commission for those rules to be effective in this state.
